# a) Report of investigation into role of Elderly Commissions in towns similar to East Windsor:

Betsy Burns contacted the towns of Windsor Locks, Ellington, and Enfield regarding their Elderly Commissions.

• **Windsor Locks** has an Elderly Commission which meets monthly; the meetings are open to the public. They are presently working on revisions

- of their bylaws. Their purpose is to reach out to the community regarding the needs of the aging community
- Ellington has a Human Services Commission rather than an Elderly Commission. The Commission is comprised of 8 members who each serve for 4 year terms. They meet monthly; the Director of Human Services and the Director of Senior Services make reports to the Commission as requested. This Commission holds citizen forums occasionally for residents to join them to discuss services they would like to see implemented. The Commission acts as advocates for social and senior services.
- Enfield has a Commission on Aging, which consists of 9 members each of whom serve 3 year terms; in addition the Commission also has 2 alternate members. Enfield sees its Commission on Aging as an integral part of Senior Services. They hold an annual breakfast symposium; the most recent symposium was hosted by a local hotel. The Commission studies the needs and develops/coordinates programs for the aging population.

Bob Cormier reported that **Rocky Hill** has no Elderly Commission; the Director of the Senior Center manages the needs of the elderly. She indicated she would like to have the ability to run more programs but isn't currently able.

The Commissioners will continue to survey additional towns.

#### b) 2018 Meeting dates:

**MOTION:** To ACCEPT the proposed Meeting dates for 2018. Cormier moved/Burns seconded/*DISCUSSION*: See Attachment A.

The Commission will continue to meet on the Fourth Monday evening at 5:30 p.m.; the 2018 Meeting dates will be February 26, March 26, April 23, September 24, and October 22. The East Windsor Housing Authorityhas agreed to provide use of the Community Room for Elderly Commission Meetings for 2018.

Both Commission Members whose terms are expiring in 2017 have expressed an interest to continue serving. The Recording Secretary has provided reappointment forms for submission to the First Selectmen's Office.

#### c) <u>2018 Budget:</u>

The Commission reviewed information on the final 2017 Budget. Due to the lack of a Municipal Agent at this time the Elderly Commission has asked the Recording Secretary to request the Treasurer's Office to refer the 2018 budget request for the Elderly Commission to Betsy Burns and Claire Badstubner.
