# **Executive Director's Report**

# April 2024

# Management:

Denisha Barnes, our new Administrative Assistant started her new position with us on Monday April 8<sup>th</sup>. She has experience in property management and other work history that gives her a well-rounded back ground. This past week she has met several of our residents and is learning quickly her new job responsibilities. We are very fortunate to have her working at Park Hill. Denisha will be attending our next Board meeting on April 17<sup>th</sup>.

On Tuesday March 26<sup>th</sup> Margaret Banker of the Greater Hartford Transit District met with our residents to discuss the new Microtranist pilot program that will provide accessible transportation for our residents in Broad Brook and travel to Enfield. The cost will be \$3.00 one way to travel anywhere in the service area. The hours will be Monday-Saturday from 8:00am-6:00pm and Sunday from noon-6:00pm. The program started April 1<sup>st</sup> and will be available for two years. If the pilot is successful, it could be a permanent means of local transportation and possibly be expanded to other towns.

On March 27<sup>th</sup> the Water Pollution Control Authority (WPCA) had their monthly meeting. Jay Ussery from Russo & Associates requested that the Housing Authority be on the agenda to request a waiver for the water connection fees for the 6 & 7 acres. Each connection is \$6,500 however the fee can be waived for municipal facilities. The Board members of the WPCA would like to see documentation that specifies that the Housing Authority is a municipal facility. The "Assistance Agreement" that we have with the State dating back to the early 70's references in this document that we are a "municipal housing authority." The same is in the 'Cooperation Agreements" for all three Park Hill development phases. Our attorney is reviewing these documents for his legal interpretation.

### Other Matters:

### 6&7 Acre Parcels/Feasibility Study

The East Windsor Planning and Zoning Commission will hold a public hearing on Tuesday April 23<sup>rd</sup> at 6:30pm to address any issues that the public may have regarding our request for a zone change for the 6 & 7 acres. Currently these two parcels are zoned for light manufacturing and single residential homes. Jay Ussery has applied on our behalf to change the zoning to an "Age Restricted Housing District." Jay and I will be attending to answer questions. The neighbors living on Windsorville Road and Reservoir Avenue received a certified letter informing them of the public meeting.

While researching various historical documents for the WPCA and the upcoming request to change the zoning for the 6 & 7 acres, it was discovered that the name "East Windsor Housing Authority" has been referred to as

"The Town of East Windsor Housing Authority" and "Housing Authority of the Town of East Windsor". To avoid any confusion in the future, our attorney is filing an affidavit with the Town of East Windsor to have the three legal names of ownership officially recorded.

### **Community Development Block Grant (CDBG)**

Amaya Architects is expected to have the Capital Needs Assessment (CNA) completed by the end of this week. The CNA is required for the State funding that we are applying for in addition to the CDBG program. The deadline to submit the CDBG application is May 31<sup>st</sup> 2024. The deadline for the State funding application is anticipated to be this summer. Our Housing Consultant Kent Lewis is confident that the applications will be submitted on time.

On April 4<sup>th</sup> East Windsor residents had an opportunity to voice any concerns at a public hearing regarding the Housing Authority submitting an application for CDBG funds. Kent Lewis our consultant gave a description of the projects for Park Hill that are included in the application. There were no negative comments. The Board of Selectmen were very supportive of our efforts.

### **Projects:**

Our maintenance staff continue to work on several vacancies and are starting on spring cleanup.

#### Vacancies

We have four vacant units and no pending move outs.
