### VII. General Discussion/ Updates:

<u>Iim Richards</u> suggested to start the meeting with Item 7, C in the agenda and introduced Margaret Smith.

Margaret Smith from the **Nutmeg Senior Rides** presented her organization and shared the information regarding the volunteer drivers. The organization was able to get the DOT requirement waived for the volunteer drivers which was not easy to accomplish. They had to actually hire a lawyer; and, with the help of the chair of transportation committee at the state legislature, a regulation was passed waiving the requirement for volunteers to have licenses.

The organization has greater flexibility to accommodate the needs of the senior citizens with the help from the staff and volunteer drivers. The law gives the flexibility to provide more services and the value of the volunteer time. They pay the volunteers for their mileage but not their time and due to the smart thinking of paid and unpaid volunteers, they continue to maintain their much-needed services to the most vulnerable population. For instance, they had customers who needed to get dialysis in times of COVID-19 when most of the transportation services were interrupted. Their rides increased from 180 to 850. In February, they had patients from Enfield Hospital be moved to the Hartford Hospital due to serious logistical issues. All the volunteers also get the worker's compensation coverage.

### D. Parking and Walkability Broad Brook Center

<u>James Richards</u> addressed the issue of safety concerns and that there was no safe pedestrian walkability from the cars to the businesses and vice versa. The issue will be discussed in the next meeting.

#### E. Zoning on Route 140

<u>Danielle Miller</u> prepared the information for Route 140. She shared with the Board that the office is trying to not change the zoning laws but revise the regulations to promote growth of businesses. Therefore, in order to eliminate some special use-regulation, the site plan review would most likely ease the burdensome requirements to nurturing the growth of businesses.
