

**EAST WINDSOR HOUSING AUTHORITY SPECIAL MEETING  
APRIL 29, 2014 MINUTES**

**1. CALL TO ORDER AND ATTENDANCE**

The Special Meeting of the Commissioners of the Housing Authority of East Windsor was called to order at 7:00 p.m. by Chairman Burnham. Present were Commissioners DeSousa, Burnham, and Simmons. Commissioner LeBoriosis entered the meeting at 7:10pm.

**2. PUBLIC COMMENTS –**

C. Mills #22 - The reason I am here is because of what was said at the last board meeting. We had a discussion about a certain resident that shall remain nameless and has been in court proceeding since July of last year. I went on line because I knew he had a court case coming up in April. Those two dates are cancelled with a new date for April 21<sup>st</sup>. Yesterday I remembered he was due to go so I went on line again to see that the court case that was supposed to on the 21<sup>st</sup> and the 22<sup>nd</sup> was suspended. No new date had been given and I was quite concerned because every other time a new date had been given. This morning I went on line, and I have a copy for each and every one of you. This is what expressed on line. There are three pages of it. The 21<sup>st</sup> trial, the summary process was the result is off by agreement of the parties. The 22<sup>nd</sup>, the very same thing. Now my question as a resident is, and having been told this is in court and nothing can be discussed, what does this mean? What does this mean an agreement has been made and he's going to be here? Does this mean he's going to be here? Does it mean that everything has been dropped and there won't be any more discussion? Now I have heard from a lot of residents they are afraid to come out and sit in their yard because of this man. He has assaulted someone, who died shortly after that. I'm not saying he was the cause of this but who knows what lead up to his death. I can tell you we had our windshield kicked in and my husband and I really felt it was him because he had words with my husband. I can't believe one person would know how to work the system the way he has and get away with it. This is what's upsetting to people here and I don't know what to tell them.

M. DeSousa - You should tell them it is being handled. The proper avenues are being taken by people who know how to take those avenues. And there is going to be a lot of things you will never know because we are not going to ever be able to say anything about it.

**3. CONTRACT WITH CL&P – Ray Mack**

Mr. Mack from CL&P was on hand to answer question regarding the lighting work CL& P proposed to do for the housing authority. The board asked for the dates to be changed and the payment time frame to be changed. Mr. Mack indicted that could be

Motion to come out of executive session duly made and approved at 9:00 p.m. No decisions were made while in executive session.
