

COLLECTION SERVICES AGREEMENT

ATTORNEY agrees to provide collection services to CLIENT for all delinquent accounts referred to ATTORNEY as follows:

- 1. CONTINGENCY FEES:** The fee is contingent upon collection of each account and shall be fifteen percent (15%) of any amount collected on non-litigated accounts. It is understood that no lawsuits will be filed on behalf of CLIENT at this time.
- 2. REMITTANCE REPORTS:** ATTORNEY agrees no later than the fifteenth day of each month following collection to submit to CLIENT a statement of the amount of all money collected during the preceding monthly period along with the remittance. The statement of collection will set forth (a) all amounts collected by the ATTORNEY and (b) all amounts paid directly to the CLIENT on accounts referred to ATTORNEY for collection.
- 3. REPORT OF DIRECT PAYMENTS:** CLIENT shall promptly report to ATTORNEY all payments received directly by CLIENT on the accounts referred to ATTORNEY for collection. Time period should be each week, if possible.
- 4. TRUST ACCOUNT:** All money collected on behalf of CLIENT shall be deposited in a trust account held by a federally insured financial institution.
- 5. APPLICATION OF PAYMENTS:** All payments shall be applied first collection fees pursuant to C.G.S. sec. 12-166 at 15% of each payment made and then to accrued interest and principal starting with the earliest tax year due and then to the succeeding tax years due.



AUTHORIZATION TO REPORT CREDIT ON DELINQUENT DEBT

CLIENT (PRINT NAME): _____

ATTORNEY: Rossi Law Offices, Ltd.

1. **CREDIT REPORTING AUTHORIZATION:** CLIENT authorizes ATTORNEY to report to any credit reporting agency delinquent debt referred for collection. Accounts to be reported will be selected by ATTORNEY meeting the account selection and reporting criteria set by ATTORNEY in accordance with law. Regardless of selection for reporting, CLIENT may notify ATTORNEY of any specific debt or debtor it does not want reported to the credit reporting agency.

2. **CREDITOR NAME ON REPORT:** The credit report will be in the name of CLIENT as the creditor and in the name of ATTORNEY as the reporting entity.

3. **WITHDRAWAL OF AUTHORIZATION:** This authorization to report credit may be withdrawn by CLIENT at any time in writing.

4. **REPORT REMOVAL RESTRICTION:** The credit report cannot be removed once reported unless clear error is shown such as identity of the debtor or lack of legal liability and that the final decision remains with the credit reporting agency as governed by law. The credit report cannot otherwise be deleted or changed in exchange for payment or for any other settlement.
