Casino- Demolition ceremony on or around Feb 28, 2018

Chief- They did come up with two different ordinances regarding the money from the casino Bids for station 2 roof replacement- the bids will go in the paper, the cost will be put in CIP for next year. Put bid in paper for April 2018

## Fire Chief's Report-49 call in Jan 2018

Chief meet with VFIS, there are some policy that we need to add to our handbook. Capt. Garner resigned from the department. I would like hold a test for the position. I would like to complete this by March. I am going to also complete performance evaluations on all the line officers. This will be done annually. Assistant Chief Austin and I think that it would be beneficial to fill that position. Discussion of Deputy Chief. FSM program is working out great. Rich Austin was involved in a motor vehicle accident January 17, 2018. No major injury. The FMS vehicle is a total loss, \$8456.50. the insurance will cover the replacement and removal of the vehicle. The police report is finished. Written warning for failure to grant right of way, fault of the district. Chief called Vic, insurance company, police did an investigation. Enfield Fire Chief got a new vehicle and will sell to the district for 8000.00. I met with the chief of BBFD who has new board and would like to discuss the possibilities of expanding the district. #### **Public Session-**

Jim Barton- We touched on the budget and town budget, our first step to rectify the double taxation, we need to stack meeting to get up there to let everyone see that something needs to be done. It is a shame that when we started taxing, the wheels came off. The real fix is to go to one district. The casino impact fund, 3million dollar money, 5.5 million-tax money. We need to be part of the 3 million dollar money. They are working on the ordinance right now. Charlie Town BOS- I do not think they were using that word for the elimination of the fire department. This will be discussed at the next BOS meeting. I will be sure that Jennifer will send out the dates of the meeting. I am going to ask Rand Stanley to send an email when they apply for the demolition permit. Last meeting you asked about the annual report, finance department said it was due to the district not being in the town budget. I have a question about the 48,000.00 charge, how do you determine that?? FM it is 6.00 a 1000.00 similar to the building department.

Are you in negations with the tribe? Vic- we have had meeting with them, they said we are part of the 3 million dollars. The tax will be about $200,000.00$ from the casino to the district. Glen we need you Charlie to help up stay in the budget. We need to fix this.
