These minutes are not official until approved at a subsequent meeting.

1. CALL TO ORDER

First Selectman Bob Maynard called the Regular Meeting to Order at 7:00 p.m. at Town Hall.

2. ATTENDANCE

Present:

Bob Maynard, First Selectman Richard P. Pippin, Jr. Deputy First Selectman Jason Bowsza, Selectman Steve Dearborn, Selectman Dale A. Nelson, Selectman

3. PLEDGE OF ALLEGIANCE

The Pledge of Allegiance was recited.

4. ADDED AGENDA ITEMS

None.

5. APPROVAL OF MEETING MINUTES

MOTION made (Nelson) and **SECONDED** (Pippin) to approve the meeting minutes of August 19, 2016. Selectman Nelson made the following clarification: On her report (Section 11C), Paul Anderson provided the Board with an update from WPCA meeting because she did not attend.

In favor: Bowsza, Dearborn, Nelson, and Pippin. Opposed: None.

6. COMMUNICATIONS

A. Resignation of Andy Hoffman from Economic Development Commission.

First Selectman Maynard read his resignation letter hereto attached as Attachment A.

7. PUBLIC PARTICIPATION

Paul Anderson, 89 Main Street, addressed the Board and encouraged everyone to attend the 250th Anniversary Celebration Committee Thursday meeting at 7 p.m. All are welcome and bring your own chair! Over the weekend he attended the ice cream social at the Osborne House and commented that they have done a phenomenal job renovating it.

8. BOARD AND COMMISSIONS RESIGNATIONS AND APPOINTMENTS

A. Resignations:

MOTION made (Pippin) and **SECONDED** (Nelson) to accept the resignation of Andy Hoffman from the Economic Development Commission with regret.

Discussion: Selectman Nelson would like Andy to resume the business interviews. She questioned if it would still be effective for him to conduct them if he is no longer a member of the commission. Selectman Dearborn said that if the businesses do not mind and let him do it then he thinks it would be fine.

In favor: Bowsza, Dearborn, Nelson, and Pippin. Opposed: None.

B. Reappointments: None.

C. New Appointments:

MOTION made (Nelson) and **SECONDED** (Pippin) to appoint Scott Morgan (R) to East Windsor 250th Anniversary Planning Committee for a term expiring 12/19/2017.

Discussion: He is a great addition and was thanked for serving again. First Selectman Maynard said he has the assistance of Dr. Kane, Superintendent of Schools since he is a member of the Board of Education.

In favor: Bowsza, Dearborn, Nelson and Pippin. Opposed: None.

MOTION made (Pippin) and **SECONDED** (Nelson) to take Agenda Items 10A and 10B out of order.

In favor: Bowsza, Dearborn, Nelson and Pippin. Opposed: None.

10. NEW BUSINESS

A. E.W. Lions Club and E.W. Parks and Recreation Department present "Bike Ride for Sight – 4th Annual Tour of East Windsor"

Melissa Maltese Director of Parks and Recreation and Mike Kreuzer, a member of the Lions Club were in attendance at the meeting to give a presentation. Mr. Kreuzer explained that this event is also known as "Tour de East Windsor", it is a bike ride that will be starting from the East Windsor High School location to allow more people to see them and maybe it will get the word out. Mr. Kreuzer presented the presentation hereto attached as Attachment B and encouraged everyone to spread the word.

B. Discussions with Carol Madore, Town Assessor regarding Crumbling foundations and revaluation update

Ms. Madore explained that the crumbling foundation issue has been around for a while and that it has come to a head because there is now a law that states when a crumbling foundation is found to be existing, the assessor must assess the property. Ms. Madore added that there are two buildings in East Windsor with crumbling foundations that she is aware of and both have had engineering studies. Currently there are a total of 200 accounts in 24 towns, however, there is potential for 20,000. That number was found by considering anything built in the same time period as the 200 accounts that have already been affected. Ms. Madore came to the Board to ask what they think she should do as far as notifying residents. A brief discussion followed.

MOTION made (Bowsza) and **SECONDED** (Pippin) to communicate the letter from the assessor to all residential property owners in town, notifying them that there has been a change in the general statutes to allow for consideration for revaluation of potential impacted properties by U.S. Mail.

In favor: Bowsza, Dearborn, Nelson, and Pippin. Opposed: None.

MOTION made (Pippin) SECONDED (Nelson) to go back to order of business. In favor: Bowsza, Dearborn, Nelson, and Pippin. Opposed: None.

9. UNFINISHED BUSINESS

A. Parliamentary Procedures

Not discussed at this meeting.

B. Barber Hill School Update

First Selectman Maynard read an email from Laurie Whitten Town Planner. Selectman Bowsza went to PZC last week and he explained to them the next step was that the PZC had to unofficially give their consent to do this. Ms. Whitten agreed to work with John Burnham or someone from the Historical Society to move that forward.

C. East Windsor Fire Protection Committee Report

First Selectman Maynard updated the Board that Carl Landolino, the Warehouse Point Fire District Attorney was at the last meeting. Attorney Landolino gave a brief overview of various scenarios we can pursue. First Selectman Maynard said that Mr. Landolino works closely with Town Attorney Hawks-Ladds and they hope to come up with next steps by the next meeting. The meetings are the 2nd and 4th Tuesdays of the month. The 4th Tuesday meetings will be held at 7 p.m. and the 2nd Tuesdays of the month will be held at 8 p.m.

Selectman Bowsza asked if fire district's attorney should be staffing them at their meetings. He added that he does not think it is appropriate to be happening.

D. East Windsor's 250th Anniversary Committee Discussion

Rebecca Talamini, Chairman reported that not too much has happened since the last meeting. Their Facebook Page is up and running, they had the ice cream social this Saturday to get public input on two logo ideas which will be discussed at their upcoming meeting. In addition, they will be discussing their search for members to join the subcommittees.

*E. Discussion of South Road

Not discussed but remains on the agenda pending receipt of additional information.

*F. Discussion of Pond Street

Not discussed but remains on the agenda pending receipt of additional information.

*G. Broad Brook Mill Site Remediation

Not discussed but remains on the agenda pending receipt of additional information.

10. NEW BUSINESS

C. Discussion of Capital Improvement Planning Projects

First Selectman Maynard said the reason he added this item is because the Town has money in the General Fund that we should spend down. He passed out Recommended CIP lists hereto attached as Attachment C. There was a brief discussion to get everyone on the same page as to what process would need to be implemented to begin allocating funds for projects.

CIP Chairman Sauerhoefer said that the Board of Finance needs to come to CIP with a budget number, next CIP can meet to decide on projects, then reach out to department heads and have them re-present what projects need to be completed. Finally, CIP can prioritize the projects, and then they go to Board of Selectmen and Board of Finance and to Town Meeting.

D. Fire Tax Collection

First Selectman Maynard explained the report he received from the Tax Collector hereto attached as Attachment D. After a brief discussion, Selectman Bowsza asked if he can have information regarding the percentage of tax payers who have not paid the Warehouse Point Fire District Tax. First Selectman Maynard said that he would have it for him at the next meeting.

E. Question regarding Public Transportation

First Selectman Maynard said that he spoke to the Park Hill resident who mentioned that the Town was working on a public transportation grant. First Selectman Maynard said he called the Department of Transportation and talked to the person in charge and was informed that the grant is no longer available. First Selectman Maynard added that some of the Dial-a-Ride money comes from there and that a small section of it is still available. He ensured the Board that next November the Town will apply for it. However, the woman he spoke to was not very encouraging because there are 3 towns applying and only \$335,000 available, however, we will still apply.

First Selectman Maynard informed the Board that he attended a CRCOG transportation meeting and went to a scoping study for Route 5. Jennifer Carrier and Tim Moore from CRCOG were in attendance. He said one person suggested putting a camera on Route 5 to conduct car counts. He also said we are working with them to come up with something to transport people from Warehouse Point to the train station.

Ms. Menard, 73 Miller Road stressed to him that the resident that brought this to her attention was focused more on in-town transportation and wanted an update on that. First Selectman Maynard said that he realizes and agrees that in-town transportation is very important and he will continue to work on this.

F. Approval of Tax Refunds

There was confusion regarding the amount of tax refunds to be approved. The Board postponed the approval of tax refunds until the next meeting.

MOTION made (Pippin) and **SECONDED** (Nelson) to reconsider Agenda Item 10A and to declare September 18th, as "The Tour de East Windsor Day and issue a proclamation.

In favor: Bowsza, Dearborn, Nelson, and Pippin. Opposed: None.

11. SELECTMEN COMMENTS AND REPORTS

A. Steve Dearborn

Selectman Dearborn had nothing to report.

Selectman Bowsza read his report hereto attached as Attachment E.

C. Dale A. Nelson

Selectman Nelson read her report hereto attached as Attachment F.

D. Richard Pippin, Jr.

He reported on the following:

- He went to the 250th Anniversary Committee Ice Cream Social, the ice cream was great and it made the front page of the Journal Inquirer
- There was no IWWA meeting
- He attended the Fire District Commission Meeting
- He attended PZC

E. Robert Maynard

First Selectman Maynard had nothing to report.

12. PUBLIC PARTICIPATION

Tom Talamini, 23 Rice Road, addressed the Board and expressed his opinion regarding the crumbling foundations issue. He feels publicizing this concrete issue is a bad idea. From years 1983-2003 there were 8 concrete companies and he is concerned that this is going to create a huge panic and the Building Department will pay the price.

Jim Barton, 158 South Water Street, addressed the Board. First, Mr. Barton said he agrees with Mr. Talamini. Second, he hopes Selectman Bowsza can get the answer to his question regarding the fire tax. Mr. Barton stated that he has heard from the Treasurer that there have been no issues or problems as far as collecting Warehouse Point Fire District taxes. He continued, "if there is 96% collection of total and fire tax, that there is no problem there but if there is someone who paid their town taxes and refused to pay their fire tax, he hopes that he gets his answer."

Mr. Barton also said the fire district has paid over \$11,000 for the collection of fire taxes. Additionally, the fire district has signed off its rights to collection of the delinquent taxes. He said those taxes do not just go away, and that \$18,000 is not gone, the town will collect those sometime in the future and there will be a profit there, especially having an 18% annual interest rate. He believes the tax collection is going pretty well.

Keith Yagaloff, addressed the Board and asked them not to not publish the names of people who have the concrete crumbling foundation issues because it tends to stigmatize those streets. Additionally, if you notify people, you are assuming the risk that you have to do it properly and they will want to hold the town accountable if it is not done properly. He also suggested to provide the public with links for more information regarding this issue. He informed the Board that most home inspectors do not feel as though it is not their obligation to tell people they have crumbling or failing foundations. He reiterated that he just wants to ensure that the Town gives the residents the information properly because he does not want anyone suing the Town.

Denise Menard, 73 Miller Road, addressed the Board. She stated that she agrees with those who are worried about crumbling foundations and many homeowners would not want the stigma of that label. She understands Attorney Yagaloff's concern and feels that the list of homeowners with crumbling foundations would be a terrible thing to put out there.

She also commented on the Unfinished Business section of the agenda. She asked about the Broad Brook Mill, where it stands and when it is getting done. She also asked the Board to clean up the Unfinished Business section if items were finished and if they are not finished, to finish them.

John Matthews, Melrose Road, addressed the Board and commented on the crumbling foundation agenda item. He said the integrity of foundation is a chemistry issue and there is test you can do to find out if a foundation is crumbling, it is called a petrographic analysis. He added that if you send a letter out like this one, you need to be prepared to give people the next steps.

Paul Anderson, 89 Main Street, addressed the Board and asked why the discussion of Pond Street is asterisked. He said that it is a major issue for taxpayers in town and if there is new information, it should be discussed under an agenda item. Mr. Anderson said Selectman Bowsza indicated during his report that Connecticut Water was going to have a meeting with someone. Mr. Anderson said that it would be nice to know what is going on regarding Pond Street.

First Selectman Maynard said that he is included in the meeting with Connecticut Water and it will be talked about in Executive Session tonight. He assured Mr. Anderson that he will be more specific at the next meeting.

Selectman Bowsza said his point in reporting on that item was to say that he was asked to do something and he did it.

The Board entered into Executive Session at 9:12 p.m.

13. EXECUTIVE SESSION

The Board came out of Executive Session at 9:52 p.m.

I am submitting my resignation as a member of the East Windsor Economic Development Commission. The EDC does nothing but talk. I joined the commission to do good things for the town. I have been a member for two and a half years, we have accomplished little. I am disappointed that I have not been able to change the commission's operating philosophy. It should be a resource for your office and that of the planning department. It is not. There appears to be no clear path for changing how the commission conducts business.

During the interviews that I conducted with local businesses on behalf of commission I also talked to the economic development directors in Enfield, South Windsor and Windsor. They described a relationship between their office and the town EDC's as cooperative and productive, a partnership. Our commission does not contribute meaningfully to the economic growth of East Windsor. I am bothered by that. With your permission I would like to resume the business interviews. I do not believe that I must be a member of the EDC to do that. I will be happy to write a report to your office after each interview. It is important that the town reach out to the business community. Personal contact can provide valuable information that can help shape East Windsor's relationship with businessmen.


The best example of the commission's inability to take action is the effort to create a Small Business Center to assist local businessmen resolve issues that trouble them. We have been talking about the Center for six months and have not been able to develop a format or date for the first meeting. Additionally the commission has not met for three months because we could not form a quorum. That is unacceptable.

The Economic Development Commission should be an important member of East Windsor's team to attract new business and interface with the town's current business community, it is not. My resignation is submitted with regrets. I feel that I have not served in the best interest of our town. That bothers me. I want to wish the Town and EDC success in developing opportunities for new and current businesses.



Selectmen's Report - August 16, 2016

On August 2, I stopped by the Friends of the Warehouse Point Library ice cream social. The Friends were kind enough to host an informal open house, talk about what they do and how they can help other groups in town. I thank them for their kind hospitality and look forward to seeing them again soon.

Following our last selectmen's meeting, as requested I called and spoke with Maureen Westbrook of CT Water Company concerning the Pond Street complaints and asking to set up a meeting between the Town and CT Water's government relations folks. Ms. Westbrook informed me that First Selectmen Maynard had set up another, separate meeting with the local folks. I've heard nothing about this since then.

On Tuesday, August 9, the Planning and Zoning Commission met. The first item on the agenda was a request for modification of a special use permit for the construction of 20 multi-family condominiums on Winkler Road. Several of these units will be designated as affordable housing under section 8 of the Connecticut General Statutes. The request was for an allowance for storage space associated with the project.

The other item on their agenda was an update on the Barber Hill School project. I updated the board and said that John Burnham and I had collected signatures from 15 of the 17 property owners in the subdivision, enough to move forward with clean title of the Board of Selectmen is comfortable assuming the risk. The next step will be to have the historical society representation meet with town staff to develop an application.

That same night the Fire Protection Committee meant to review options available to correct the issues associated with the Warehouse Point Fire District. Fire District attorney Carl Landolino gave an update about conversations held between him and the town attorney to find workable, allowable solutions. Options include elimination of the district, expansion of the district, creation of a new district in Broad Brook, refunding the Warehouse Point Fire District funding for this year, and to do nothing at all.
