MINUTES OF REGULAR MEETING

1. CALL TO ORDER

First Selectman Robert Maynard called the meeting to Order at 7:00 p.m., in the East Windsor Town Hall, 11 Rye Street, East Windsor, Connecticut.

2. PLEDGE OF ALLEGIANCE

Everyone present stood and recited the Pledge of Allegiance.

3. AGENDA APPROVAL

MOTION made by (Pippin) and SECONDED by (Nelson) to approve the Agenda, as amended, to add 11E-Discussion of Melrose Bridge and 11F- Resolution About Behavior at the Gravel Pits and to move 11A- Presentation by the American Heritage River commission and 11E-Discussion of Melrose Bridge to before 10-Unfinfished Business.

In Favor: S. Dearborn, J. Bowsza, D. Nelson and R. Pippin Opposed: None Motion: PASSED

4. ATTENDANCE

Robert Maynard, First Selectman Richard P. Pippin, Jr., Deputy First Selectman Jason E. Bowsza, Selectman Dale Nelson, Selectwoman Steve Dearborn, Selectman

5. PARLIAMENTARY PROCEDURES

Mr. Maynard reminded everyone not to interrupt people when they have the floor and only to speak when recognized.

Mr. Bowsza stated that it might be worth doing what the Board of Finance did with parliamentary procedures in their Agenda for their next meeting.

6. APPROVAL OF MEETING MINUTES

MOTION made by (Pippin) and SECONDED by (Nelson) to accept the Regular Meeting Minutes from the November 15, 2016 meeting, as is.

In Favor: J. Bowsza, D. Nelson, S. Dearborn and R. Pippin Opposed: None Motion: PASSED

7. COMMUNICATIONS

Mr. Maynard read a response to an e-mail from Mark Simmons regarding an Ethics Commission Meeting. Mr. Simmons stated in the e-mail that a tentative meeting had been set for January 3, 2017.

Mr. Maynard apologized for the words he said to the press about the incident that happened at the gravel pits over the weekend. He said he should have taken a stronger stand and he did not express himself very well. He said by not taking a stronger stand it was seen as passively condoning the behavior. In the future he will take a stronger stand on issues like this.

8. PUBLIC PARTICIPATION

Tom Talamini had surgery and a card was sent around the room for anyone that wished to sign it and send well wishes.

Rick LeBorious stated that the Democratic Town Committee adopted a Resolution condemning the racism, bigotry and the intolerance that happened over the weekend. They asked that the Governing Boards of the town of East Windsor do the same.

Gil Hayes asked Mr. Bowsza which parliamentary procedures the Board of Finance has that he referred to earlier. Mr. Bowsza stated that it was a "cheat sheet" for Robert's Rules of Order that was attached to the Board of Finance Agenda for their next meeting. He stated that it just the newest version of Robert's Rules of Order, what the most common ones are and the appropriate uses for it are. He stated it is nothing more than a refresher for Board members.

John Burnham stated he was unable to attend the last Board of Selectmen meeting and wanted to clarify if the Agenda item 11C Discussion of the Warehouse Point Fire District MOU was the report of the Warehouse Point Fire Commission and if it was he would like the Board to vote on accepting the recommendations of the Fire Commission. Mr. Maynard stated that it was not the same thing and that the Board thought that the next move was for the Warehouse Point Fire District to accept the State Statute regarding fire districts. Mr. Maynard said it could be put on

the agenda for the next meeting. Mr. Burnham would like to have it on the next agenda so it could be talked about. A discussion ensued.

Steve Smith stated the discussion last meeting about the MOU was whether or not to keep the current taxation situation with the Warehouse Point Fire District. Mr. Maynard stated that it is on the Agenda and Mr. Pippin stated that is when it should be brought up.

D. James Barton stated that at the last meeting all that was done about the Fire Commission was to accept the report and it should be indorsed. In regards to the MOU he urged the Board not to get out of that and not to eliminate it. He thinks it is fine if the Board wants to renegotiate it but urges them not to eliminate the agreement.

Steve Smith wants the MOU agreement killed.

Mr. Pippin states to Mr. Maynard that this is an Agenda item and it should not be talked about until it comes up later. It was then stated that this is the only place it can be discussed (Public Participation) since a member of the public is not supposed to comment on an Agenda item while it is being discussed.

James P Barton, 108 Main Street, by killing the MOU this Board is further hurting the tax payers of Warehouse Point because the Fire District is going to have to hire a Tax Collector, someone to send out the bills, everything is going to be duplicated to what the Town Tax Collector already does. By squashing the MOU or killing it you are further hurting the tax payers of Warehouse Point. It is a good deal for the Town to collect the taxes, they get 18% if someone does not pay their taxes. Mr. Maynard says the Board wants to renegotiate it not eliminate it.

Steve Smith states that the report is right now that since collecting taxes since August 1st, \$4800.00 has not been collected so getting the 18% is taking an awfully long time.

11A. Presentation by the American Heritage River Commission:

Dr. Martin and one of her students, JoAnn, came and gave a lengthy presentation to the audience about the testing that had been done weekly since April of this year.

MOTION made by (Pippin) and SECONDED by (Bowsza) to recess for a Town Meeting at 7:30 p.m.

In Favor: J. Bowsza, D. Nelson, S. Dearborn and R. Pippin Opposed: None Motion: PASSED Board of Selectmen Meeting was Called Back into Order by Mr. Maynard at 7:47 p.m.

The presentation continued once the meeting was called back to order.

Dr. Martin explained how 52 samples were taken in 2015 and 95 samples were collected in 2016. These samples were collected in various areas of the Skantic River. With all of these samples, which consist of three towns, East Windsor, Enfield and Somers, they can start backtracking to see where the contaminants come from. They are hoping to do this again next year. A lengthy discussion ensued.

11E. Discussion of Melrose Bridge:

They are putting in for a grant for the restoration of the old Melrose Bridge. If they are able to get the grant and make a pedestrian bridge it will open up about twelve acres of Town land to the Enfield line to Canyon on the Ridge. This would double the amount of Green Way Trails in the town. A discussion ensued.

MOTION made by (Pippin) and SECONDED by (Bowsza) to approve the grant process to rehabilitate the Melrose Bridge and develop additional green way trails.

In Favor: J. Bowsza, D. Nelson, S. Dearborn and R. Pippin Opposed: None Motion: PASSED

10. UNFINISHED BUSINESS

Mr. Maynard reminded everyone not to interrupt people when they have the floor and only to speak when recognized.

A. East Windsor's 250th Anniversary Commission Report:

Rebecca Talamini reported that everything was moving forward and there was nothing new to report. Meetings are held the first and third Thursdays at 7:00p.m.inside the Osbourne House.

Miss Talamini stated that one of their objectives is to help the Veteran's Commission. A representative from the Veteran's Commission spoke and said they had raise \$22,000 so far through fundraising. He discussed that they had just had a road race and there were 334 runners and he thanked many people that donated money and time to their cause.

B. Barber Hill School House:

It was stated that it is in the hands of the attorneys and they are working it out. They are getting very close, there are no hold ups on either side just waiting on paperwork and it will be done anytime.

C. Discussion of CIP:

Mr. Maynard stated he had taken some of the projects from the worksheet from last meeting and pulled out some things he felt could be funded from the Fund Balance. He asked the Board Members to look them over and possibly at the next meeting pick some to fund. They are things that need to be done and are \$20,000 and above. A brief discussion ensued.

A request was made by CIP for the Broad Brook Fire Department for a new server. This is a high priority because their existing server is about to crash and there many issues with it. Mr. Pippin asked if it was an emergency and he was told yes it was. A discussion ensued. See Exhibit A

MOTION made by (Nelson) and SECONDED by (Pippin) to send the Detailed Capital Budget Request from the Broad Brook Fire Department to the Board of Finance and Town Meeting if needed.

AMENDED MOTION

MOTION made by (Nelson) and SECONDED by (Pippin) to send the Detailed Capital Budget Request from the Broad Brook Fire Department, not to exceed \$33,381, to the Board of Finance and Town Meeting if needed.

In Favor: D. Nelson, S. Dearborn and R. Pippin Opposed: J. Bowsza Motion: PASSED

D. Discussion of South Road

Mr. Maynard stated that this was discussed at the last meeting and as requested a representative from the East Windsor Housing Authority was present to discuss this matter. There were concerns from Mr. Bowsza that some of the Housing Authority were not on board with the Termination of Management Agreement for South and Phelps Roads Development. After a brief discussion a motion was made.

MOTION made by (Pippin) and SECONDED by (Dearborn) to sign and send the letter to the East Windsor Housing Authority regarding the Termination of Management Agreement for the South and Phelps Development.

In Favor: S. Dearborn and R. Pippin Opposed: J. Bowsza and D. Nelson Motion: PASSED

First Selectman, R. Maynard had to cast a vote to break the tie, he voted In Favor. The letter will be signed and sent out.

Also a letter was submitted for review about repairs and costs to South Road for dealing with roots and sewer line.

E. Discussion of Farm Leases:

The Tschummi Farm lease was looked over to make sure the proper changes were made to the lease and both parties, Mr. Maynard and Mr. Reichle, signed the lease.

F. Discussion of Casino and Community Outreach:

Mr. Maynard readdressed the same topics as he did the last meeting. There really isn't much to discuss at this point since five locations are still being considered for the casino. If East Windsor becomes one of the two finalists then there will be a lot more to discuss. Mr. Maynard again stated that it would bring in about \$4 million in tax revenue and about 2,000 jobs. The casino would give priority to residents of East Windsor for hiring. A lengthy discussion ensued and the public was allowed to speak and have their concerns addressed.

Bob Belfour, 11 Sharon Lane, when will the know more about this process and when can they have a presentation ready? He would like it ASAP. Mr. Bowsza stated that it is going to need legislative approval anyway and they don't go back into session until January, 2017. Mr. Bowsza thinks it will happen fairly quickly so they don't miss their legislative window. If they miss the legislative process they will have to wait another thirteen months. He is opposed to the casino and he is concerned with the traffic. What will the town do with the money? Mr. Maynard said that was a good question and that is something to think about.

Denise Menard, 73 Miller Road, she is assuming that they are buying the property and wants to know the Town's part in building the casino. Mr. Maynard said the MMCT will purchase the land and they would hire someone to build it. Mr. Pippin stated that it is too early in the game to speculate and to really be discussing this.

Kate Keritrell wanted to know what type of facility they are going to build. Is it just a gaming facility or are there going to be restaurants? Mr. Maynard didn't have any idea yet and thought it was a good question and thought it should be brought up to the MMCT.

Jim Richards thinks that the Town should look at the plan as a whole and all the good positive things going on around us even if the casino doesn't go through. A lengthy discussion ensued.

Bob Belfour wanted to know how long it will take to build the casino. Mr. Maynard was not sure and he said he would check into it.

A resident from 153 Melrose Road, What will happen to Big Y? Mr. Maynard was not sure but they rent the building and it would have to be looked at.

Mary Hefner, 2 Napoleon Drive, thinks she is in favor of the casino and thinks that a message needs to go out to the community. Wants everyone to think about what the Town could do with the money. She gave a few examples. Mr. Maynard asked when a good time would be for a presentation. He thinks that the high school auditorium and an evening would be best.

Mr. Bowsza says one of the things that the Town can control is the development agreement.

Paul Anderson, a meeting before the holidays is not a good thing since they can't even get approval until January the earliest.

Kathy Simonelli, thinks that a presentation is good thing to get a road map of what is going on. It will be shy on details a face to face would be good sooner than later.

A resident from Church Street wanted to know who would be involved with the negotiations. Mr. Maynard stated that he and the Board of Selectmen and many agencies would be involved in the negotiations.

Jim Barton stated he thought that the meeting should get back to the Agenda items.

B. Discussion of FY 17-18 Budget:

A budget letter was presented and is sent out every year on December 1st. It needs to go to the Board of Finance. Mr. Pippin states that the chatter needs to be changed to charter and it is in there many times spelled wrong. A brief discussion ensued. It will be sent out.

C. Discussion of Warehouse Point Fire District MOU:

Mr. Maynard thinks it is time to give the 120 days' notice to talk and get an agreement together.

Steve Smith is concerned about the \$4,800 of uncollected taxes and the 18% is just taking too long.

Jim Barton feels this is a non-issue and people are trying to make it into an issue. It is the same delinquent tax payers that owe property taxes also and to gripe about the \$4,800 is a waste of time.

Jim Richards has a concern with the perception of the contract with the Town. They are two separate entities and the budgets are separate.

After a brief discussion a motion was made.

MOTION made by (Nelson) and SECONDED by (Bowsza) to accept the Warehouse Point Fire District MOU, as dated, April 19, 2016, continuing with no changes.

First Selectman, R. Maynard had to cast a vote to break the tie, he voted In Favor.

Be it therefore resolved that the Town of East Windsor affirms that no acts of hate or persecution are welcomed in our town, in any way, at any time.

There are a few projects they want to do (seventeen). Last comment, the Town video solicits the buying of a website and he was very upset by the back door scams. He was very upset about it.

Paul Anderson addressed the virtual permit software and East Windsor was not on the list of towns that had purchased it Mr. Maynard stated East Windsor was not on there because it is not online for contractors to use yet.

Gil would like to address the incidents at the pits. He sits on the Police Commission and that area is under surveillance and the ATV activity is nothing new. The only thing that is new is the person with the hood on. He feels that Mr. Maynard was bashed, unfairly, on social media for comments that he said to the media. The media shoved the video in Mr. Maynard's face and then asked him to comment on it. He realizes that Mr. Maynard apologized but feels that he was unfairly bashed. He does feel Mr. Maynard has a lot to learn and he means no disrespect and he thanks him for serving on the Board. He also does not consider Mr. Maynard racist.

Mary Hefner, 2 Napoleon Road, is glad that something had been brought up about the pits. She isn't sure exactly where these pits are located but she knows they are a problem. She was wondering if the Town had any plans to purchase the property so they could do something about the issues going on there. Her road has had increased traffic and her road is a dead end road. Many ATV's and motorcycles go up and down the road.

Mr. Maynard says the property is huge, they call it the pits because there are more than one. He says it runs from Apothecary to Plantation to Wapping. There are many ways into the property because it is so large. The State may have to come in to deal with the problem.

Mr. Pippin call the police if you see vehicles or have a noise complaint. Although, he says some people have written permission to be on and ride on the property.

Mrs. Nelson states that there are about 500 acres so it is hard to police. She states that once they have been found parting in one spot they just move because the area is so huge with many ways in.

Bill Loos, Melrose Road, Broad Brook Mill Property had a few Fire Inspectors from Hamilton Standard stop at the station and stated they want to take down the old town garage and the fire department may be able to burn it down for practice. They told him the old mills are full of mold and just about everything down there is shot. Hamilton Standard has taken over the property so hopefully something will finally get done.

Kathy Simonelli, addressed a signage issue, she wanted to clarify if a sign could have the hours of operation the business on it, she was told it could not. She was told the Broad Brook Library was told they couldn't have the hours on it. She was informed that that was not the case that the problem was that it was oversized. Mr. Pippin stated they could regulate size not content.

Executive Summary

Business Need

Town of East Windsor is seeking Professional Technical Services for installation of a new server and equipment at the Broad Brook Fire Department.

Selectmen's Report - 11/15/16

Well, it's certainly been an interesting few weeks.

First, I want to congratulate everyone who was elected to office last week. I sincerely wish them the best of luck. Their success is our success.

I spent about 11 hours on Election Day standing at the polls, asking people what they wanted to see the Town work towards in the next year. I thought I'd share some of these thoughts in the hopes that it may advise our agenda as a board for the next 12 months.

Not surprisingly, I heard a lot about our schools. People want to see improvements there, but they also want to have confidence in the school district, and want to see more transparency. This came up a lot.

People were concerned about taxes going up every year, but they also wanted to see infrastructure improvements and they wanted to see the Warehouse Point Fire District reinstated into the Town budget.

People were concerned about unaddressed blight, about streetlight outages, the speed at which development has happened, the need to examine regionalism opportunities, and the need to preserve our rural character.

People spoke about their desire to see the Broad Brook Mill remediated, the need to invest in Broad Brook Center, reinstitution of middle school sports, support for universal pre-K, and the need for more stringent speed limit enforcement.

People also talked about their support for the work done by our human services department, and about their fears and concerns regarding the heroine epidemic. We need to do something about this.

I could go on and on about the the conversations that happened last week. The bottom line is, there is work to be done and I will continue to bring these up to the board over the next year. Hopefully, we can make some headway on some of these issues.

I missed the Planning and Zoning Committee meeting due to the election.

On Saturday, 11/12, I attended a Board of Education workshop where district staff, parents and members of the community discussed the strategic plan for the district. About 50 people were there, and discussed topics that included curriculum, infrastructure, communication, and other topics.

Finally, I'd like to comment on the video that surfaced yesterday. I've seen the news reports about the KKK incident that occurred in East Windsor over the weekend. First, I want to thank the East Windsor Police Department, and specifically Detective Sergeant Matthew Carl, for the very professional way that the department has handled this breaking news and denounced it.

East Windsor is better than this. We are not a community that is bigoted, hateful and xenophobic. There is no place for hate crimes that make people feel devalued, unwelcomed and unsafe. I've knocked on thousands of doors in our town, and have had an opportunity to get to know the families here. These families are why I've stayed.

The type of behavior that happened this weekend is not who we are. We are a community that values inclusion. We value tolerance. We value compassion and understanding. We are a caring place where anyone is welcomed.

This weekend's event was not just "kids being kids." It was a reminder to all of us that hate and bigotry are part of the world we live in, and that we need to renew our commitment to each other and to ourselves that we need to be part of the solution that makes East Windsor, our state, and our country a better place.
