TIME AND PLACE OF BUDGET WORKSHOP MEETING:

First Seletman Maynard called the Meeting to Order at 7:02 p.m. in the Town Hall Meeting Room, 11 Rye Street, Broad Brook, CT.

ATTENDANCE: See Page 1.

PUBLIC PARTICIPATION:

Paul Anderson, 89 Main Street, Broad Brook: Mr. Anderson reported he dropped off brochures announcing the Broad Brook Library's 100th Anniversary this year. Mr. Anderson reported they are dead serious about doing business this year, and for some time; they're looking for support from the Town. Mr. Anderson felt it's completely unacceptable, unreasonable, and unfair the way the Broad Brook Library has been treated over the past several years with regard to funding. Mr. Anderson felt if the Warehouse Point Library gets funded then the Broad Brook Library should be funded as well. Referencing the brochure, First Selectman Maynard noted the Broad Brook Library is a 501C organization; Mr. Anderson concurred.

<u>APPROVAL OF WAREHOUSE POINT FIRE DISTRICT MEMORANDUM OF</u> UNDERSTANDING:

Treasurer O'Toole noted the Board had previously funded this line item for \$232,000.

Lengthy discussion involved the purpose and language of the MOU. Selectman Szymanski wanted a term included in the MOU, such as the Fiscal Year. Fiscal Year 2019 – 2020 was initially added to the final "WHEREAS" paragraph during discussion. Selectman Bowsza questioned the purpose and intention of the MOU; First Selectman Maynard felt the intention was to equalize taxes for all taxpayers. Selectman Szymanski reiterated he felt the document was to have a term of one fiscal year while the departments work out their consolidation, with everyone looking for a target of the following fiscal year when it would be one fire department and this wouldn't be an issue. Selectman Bowsza questioned what's the MOU trying to do? Treasurer O'Toole suggested it's to get them to reduce their mill rate; First Selectman Maynard continued to clarify that the MOU equalized the taxes townwide. . Chief Barton advised the Board that the Board of Finance wanted this MOU, and that they wanted the MOU as a guiding document over the changing administrations. Deputy First Selectman Dearborn noted discussion of making the whole town one fire district, which becomes a tax on the people on the Broad Brook side of town. He noted the need to support a single fire department but felt he couldn't give away taxpayer money until the issue is resolved. First Selectman Maynard reiterated the MOU is the Town trying to equalize the taxes

MOTION: To APPROVE the Warehouse Point Fire District Memorandum of Understanding (MOU).

Maynard moved/Szymanski seconded/

DISCUSSION: Selectman Bowsza questioned that this MOU would commit the Town for more than the Fiscal Year? First Selectman Maynard felt not. Selectman Bowsza questioned if he meant by the Severability Clause? First Selectman Maynard concurred; he also suggested that the Board of Selectmen (BOS) and the Board of Finance (BOF) can choose zero for the budget line item. Selectman Szymanski guestioned that the BOF wanted this MOU without a restriction of one year? Treasurer O'Toole indicated the BOF really didn't talk about that; they just talked about how would they know that the mill rate was going to be reduced if you guys (the BOS) do have a MOU. Treasurer O'Toole suggested the BOF couldn't set the policy, so they just gave the Warehouse Point Fire District (WHPF District) direction that they had to sit down with the BOS and put a policy together that ensures that if we give the WHPF District money there's going to be an offset in the taxpayer bill on the Warehouse Point side of town. They didn't talk about one year; they talked about that they would like the process to be done but wanting it to be done and getting there might be very different things. Selectman Szymanski requested First Selectman Maynard seek clarity from the BOF as he would rather enter into this MOU for one year; First Selectman Maynard agreed as he would prefer a one year term as well. Selectman Bowsza suggesting delaying the vote until Wednesday's meeting to discuss the issue with the BOF Chairman. Treasurer O'Toole offered to contact the BOF Chairman; she requested clarification that the question was that the BOS are talking about restricting the MOU to one year? The Board concurred.

First Selectman Maynard withdrew his motion, Selectman Szymanski withdrew his second. This item will appear on the BOS Budget Workshop scheduled for 6:00 p.m. Wednesday, March 13, 2019 in the Town Hall Meeting Room.

TREASURER – 410500:

MOTION: To APPROVE the Treasurer's Budget at \$243,354 for a 2.59% increase.

Maynard moved/Szymanski seconded/

DISCUSSION: Selectman Bowsza questioned why over-time was being provided for the Treasurer's Office? Treasurer O'Toole reported over-time for the office has been provided via comp time but that takes staff out of the office; this funds the overtime more realistically. The overtime is funded at an hourly rate. Selectman Bowsza questioned who's eligible for longevity? Treasurer O'Toole reported everyone but herself. Selectman Bowsza questioned what's driving the increase in Professional Services? Treasurer O'Toole reported Paylocity, which is the payroll vendor.

<u>ASSESSOR – 410700:</u>

MOTION: To APPROVE the Budget request for the Assessor's Office at \$194,615 for a

1.90% increase.

Maynard moved/Hoffman seconded/

DISCUSSION: Selectman Bowsza questions what's driving Travel expenses? Treasurer O'Toole noted staff is going for certification. Selectman Bowsza questioned if the continuing education units couldn't be done online? Treasurer O'Toole replied perhaps but she noted staff are using the Town car more now that it's a reliable vehicle. Selectman Bowsza questioned what's in the Supplies line; it appears light. Treasurer O'Toole didn't have the detail available. She felt it might be the purchase of the pricing books. Selectman Bowsza questioned if they were annual periodicals or can they last longer? Deputy First Selectman Dearborn questioned the amount of the Budget request increase? Treasurer O'Toole cited increase is 1.9%

HUMAN SERVICES (Social Services) – 411700:

Treasurer O'Toole noted the Board previously reduced the requested additional part-time position but left in the funding for the Youth Services Bureau Coordinator. Treasurer O'Toole noted this budget is showing an increase due to the funding to match the \$14,000 grant received for this position. The budget approved in May of 2018 didn't show any funding for this position.

MOTION: To APPROVE the Budget request for the Social Services Department at

\$152,907 for a 23.86% increase.

Szymanski moved/Maynard seconded/DISCUSSION: None.

VOTE: In Favor: Unanimous (Maynard/Dearborn/Bowsza/Hoffman/Szymanski)

POLICE DEPARTMENT – 510200:

Skip over this department and return to discussion later in the meeting.

EMERGENCY MANAGEMENT – 510300:

MOTION: To APPROVE the Budget request for Emergency Management at \$18,206

for a 1.87% increase.

Bowsza moved/Hoffman seconded/DISCUSSION: None.

COMMUNICATIONS – 510400:

MOTION: To APPROVE the Budget request for Communications for \$49,168 for a

7.67% decrease.

Maynard moved/Szymanski seconded/DISCUSSION: None.

VOTE: In Favor: Unanimous (Maynard/Dearborn/Bowsza/Hoffman/Szymanski)

FIRE SERVICES/BROAD BROOK FIRE DEPT - 511000:

Treasurer O'Toole clarified that the lump sum for the Warehouse Point Fire District was reduced from \$464,000 to \$232,000, which is 1 1/2 % of the Town Government Budget increase. Deputy First Selectman Dearborn cited that if the Warehouse Point Fire District wasn't in this budget the Town Government side of the budget would be below 2%; Treasurer O'Toole concurred.

MOTION: To APPROVE the Budget request for Fire Services/Broad Brook Fire

Department for \$696,000 for a 61.11% increase.

Maynard moved/Szymanski seconded/

<u>DISCUSSION:</u> Deputy First Selectman Dearborn indicated he would vote for the budget but you have Warehouse Point Fire District in here; I'm not going to approve that. I'll vote for the Broad Brook Fire Department but not the \$232,000. Selectman Bowsza indicated he will support that for now but he reserves his option to come back and revisit that depending on what the ending overall package is. Selectman Hoffman wasn't comfortable with changing something that's working. He suggested he realized with all the disparities and all that kind of stuff, but we're changing something that's working. We have to fix the problem, and I think by doing this, even as Selectman Szymanski suggested, for one year, it just takes the pressure off of fixing it. Deputy First Selectman Dearborn indicated that's how he looked at it exactly; it doesn't give them any incentive. Selectman Hoffman cited it's a very complex issue. Deputy First Selectman Dearborn indicated he'll go with what Selectman Bowsza just said, he'll vote but he's reserving the right to change his mind

VOTE: In Favor: Unanimous (Maynard/Dearborn/Bowsza/Hoffman/Szymanski)

HUMAN SERVICES (Social Services) – 411700:

Treasurer O'Toole noted the Social Services Budget, and the Public Works Budgets, have "bumps" in the salary lines; the Board needs to review both of those budgets and revise the salary lines accordingly.

Selectman Szymanski requested clarification of the Non-Negotiated Salaries line under Contingency. Treasurer O'Toole noted that line is where the salary changes for all the unions which are out of contract would be reflected.

MOTION: To RECONSIDER the Social Services Budget request.

Bowsza moved/Maynard seconded/

<u>DISCUSSION:</u> Treasurer O'Toole cited this budget also includes funding for step increases for two current employees. While the employees' job descriptions haven't changed, and the job titles are separate, the employees feel they are doing the same job. Treasurer O'Toole recalled this was part of the reorganization of the three departments. Selectman Szymanski recalled that the Board was told at the time of the reorganization that there would be no changes.

<u>DISCUSSION:</u> Selectman Szymanski questioned what would happen if the Town bonded for projects in the next Fiscal Year? Treasurer O'Toole cited the initiation of payments would begin dependent on the timing of the bond issuance. She cited the complexity of the proposed projects, which will require significant design work prior to bonding. Treasurer O'Toole felt the Board would be discussing bonding for those projects at this time next year.

Discussion occurred regarding the staff realignment; ultimately no action taken. See discussion under Planning Deprtment.

Discussion followed regarding the strategic planning position, which would become part of the supervisor's union, vs. a part-time position with administrative duties to include overseeing View Permit.
