Mr. Martin suggested his question is the WPCA oversees the Plant Superintendent and his operation. So, how does the Plant Superintendent get the authority to essentially veto someone to his board? And, additionally, as you probably know, the WPCA only has five members and it has two vacancies. So, everybody has to attend in order to even get a quorum. Mr. Martin recalled that at the last meeting the Board Chairman told you that he wouldn't be able to hold a meeting for the rest of this year if he couldn't get another member.

Mr. Martin indicated his main concern is, you have an application for an appointment, the application contained some references and so forth, but it seems like this appointment was derailed simply by the Plant Superindent, who, I believe, has a conflict of interest.

First Selectman Bowsza thanked Mr. Martin for his comments.

First Selectman Bowsza indicated he is returning to the posted Agenda of the Selectmen's Meeting. He noted the next item of business was 8C – (8 - NEW BUSINESS – Item C - Discuss ARPA Survey Results Deeper Dive),

8. C. <u>Discuss ARPA Survey Results Deeper Dive:</u>

First Selectman Bowsza began a review of the ARPA Survey results, referencing his PowerPoint presentation. *Please see Attachment A for the complete survey results*, following is a brief summary of highlights of the report.

First Selectman Bowsza reported 9,000 surveys discussing the best use of the American Rescue Plan funds were made available to 9,000 homes using the registered voters list. In response 700 comments were received. 70% of the respondents were 55 years old, or older, approximately 35% of the population falls within that age group.

First Selectman Bowsza suggested the next slide identifies the items by importance to the respondents. Of the six areas identified in the survey three were identified as most important, those areas, and their scale of importance on a possible scale of 5, were: hard infrastructure (4.12), environmental quality (3.87), and quality of life (3.78).

Reviewing the 700+ responses First Selectman Bowsza identified 148 unique response categories. From those categories he then removed items which are either already happening, or aren't feasible.

First Selectman Bowsza then reviewed several slides which reflected categories which received a number of responses and were the most popular to the respondents. Those categories included: road improvements, school related projects, drainage projects, public safety improvements, tree related issues, farmland preservation, blight concerns/economic development, recreation, playgrounds/park improvements, water quality, facilities improvements, cost assistance/tax break, public safety staffing, environmental projects, EV charging stations, social services, tourism/rails to trails, and quality of life.

First Selectman Bowsza asked the Board for comments.

<u>Paul Anderson, 89 Main Street, Broad Brook</u>, requested a hard copy to review; First Selectman Bowsza indicated he would provide the requested copy.

Deputy First Selectman DeSousa cited the work that must have gone into reviewing the survey results.

Selectman Muska questioned if the American Heritage River Commission has a brochure that identifies the recreational walking areas that we currently have? She cited the availability of current walking areas and questioned if people are aware of what those areas are. Finance Director O'Toole suggested some type of brochure was available. Albert Grant, Chairman of the Conservation Commission, noted there is a State property in Melrose that includes a walking trail. Noting the Commission's limited manpower, Chairman Grant suggested there are other places in town which would need to be maintained.

Selectman DeSousa noted areas in town that were set aside intentionally for open space along the Connecticut River years ago, she noted areas behind Winton Park and areas further down. She suggested it might be worth asking perhaps the Planning Department to look into that. Chairman Grant suggested at the end of Plantation Road there is a significant opportunity for a trail head, and preservation of farmland allows the public to have access. Deputy First Selectman DeSousa suggested Park and Rec might be able to provide walking trails as well.

Selectman Baker joined the conversation remotely. Continuing that conversation regarding the walking trails, Selectman Baker suggested the American Heritage River Commission put together one "official" walking trail in Melrose. He noted the Town owns land across the street and a bridge was established across the Scantic River to give access to the trail. Selectman Baker reported he understands they have plans on the side where that access is now to extend the trail, which would require more materials for bridges. Although they did replace some bridges recently there's more work to be done, he suggested refreshing their plan – a lot could be done for a little bit of money. Selectman Baker suggested that's the most used, and popular, walking trail we have in town.

First Selectman Bowsza cited Selectman Baker's comment that a lot can be done with a small amount of money. He suggested a consideration for the Board is what can we get done for as little as possible to get as much done as possible versus \$2 million worth of roads, which the Town could also use.

Selectman Baker reported he is also a big advocate for connecting the residential area to the commercial area, especially in Warehouse Point, which he was glad to see represented in the survey as well. He suggested the connectivity could be provided via sidewalks and bike lanes. With the transit-oriented work that's being done in Windsor Locks we should be looking at what we can do so people can walk to their jobs or visit various establishments without the use of a car. Selectman Baker suggested some of that work has already been done under the Route 5 Study, he suggested perhaps the Board could use some of the recommendations from that report.

First Selectman Bowsza referenced page 29 of his PowerPoint, he suggested the Board could discuss each of the top priorities in successive meetings.

C. Alan Baker:

Selectman Baker suggested **Planning and Zoning** had a couple of things going on, but the one thing he felt was important to report on was the Public Hearing they opened for 297 North Road, Special Use Permit renewal for a soil management facility. This permit is different from our gravel pits in that they will be taking soil in. This makes it more complex in that they need to test the soil, and have it removed if it tests for any hazardous materials instead of spreading it over the old dump site. There are a bunch of rules for how testing and procedures for how testing is managed for these types of permits, so Town Staff is reviewing it make sure everyone knows the process. Much more information will be discussed at the next meeting. It's important that we get this right because of the proximity to the Scantic River.

Selectman Baker reported the **Broad Brook Fire Commissioners** had their normal meeting. The one thing that came out of that for the Selectmen is they again discussed getting on the Selectmen's agenda to talk about the Fire Department space needs in the short term in regards to the Community Center as well as a longer term strategy. They are looking

Selectman Nordell reported he also attended the **Board of Education** Meeting. I was there with the PTO. The kids are getting ready for school. The PTO's first meeting is September 8th at the Elementary School Cafeteria at 7 o'clock, that's next Thursday. First Selectman Bowsza advised the Board the Town is having a Freedom of Information Training session next Thursday at 5:30 which went out to all Town Staff. Attorney Sommeruga has written several books on the Freedom of Information Act, and this training session is in conjunction with the Board of Education.

11. PUBLIC PARTICIPATION:

First Selectman Bowsza noted the second opportunity for public participation. He noted no one is present in-person, he offered the opportunity to comment to the remote participants.

The remote participant didn't identify herself but noted her address as <u>53</u> Prospect Hill Drive. She noted she has two comments/questions.

The resident reported she noticed there isn't a camera on the ballot drop box at Town Hall, and she isn't sure if there is one at the Annex, or if there are other

locations. The resident wondered if that was on the agenda for the Board of Selectmen to take care of in order to secure election integrity.

First Selectman Bowsza didn't recall a drop box at the Annex, but there is a drop box at Town Hall. First Selectman Bowsza suggested it's captured on the internal cameras in the hallway. The resident requested clarification that there was a camera at the drop box; First Selectman Bowsza replied affirmatively.

The resident then noted she was disappointed earlier when we had 23 minutes to discuss \$920,000 in expenditures for 4 different projects and there was nothing for the townspeople to have to make any kind of educated, informed vote on it. For instance, the high school roof, she was shocked to see that it was only \$200,000. The resident suggested she knows that it will require a lot more than that and she hopes that it gets done sooner rather than later, it's been a project in the works for a long time. But another thing, the loader for Public Works, \$300,000, where did that number come from, how is there a way for us to verify that that is what specific loader costs and not \$280,000 and somebody's pocketing \$20,000. How do we know it went out for 3 bids and not just 1. How can the townspeople access information like this before they are forced to make a decision on a million dollars in 20 minutes?

First Selectman Bowsza queried the remote participants again, no one else requested to be acknowledged.

He suggested a motion to adjourn would be in order.






Total Responses by Age

First Selectman's Report – September 1, 2022

This week marked the beginning of the school year, and I want to wish all East Windsor students a great year ahead. The Town Department of Public Works has been working hard last week and this week to make sure the grounds were ready for the return of students.

The Town's new Building Official, Ken Rich, has been with us for a little over a month, and has completely caught up on all outstanding building inspections and plan reviews. Ken has already brought forward several long-overdue ideas about how to make that department as helpful to residents and businesses in our community as possible, and we are very excited to have Ken onboard.

Just a reminder that on the November ballot, there will be a question authorizing the proposed community center. Over the last several months, preliminary plans and conversations have taken place to have the Town assume operations at Scout Hall, add an approximately 8,000 square foot addition onto it, and locate all of our Community Services Departments, which include Social Services, Senior Services and Parks and Recreation, on that one campus. The final project plans should be in hand by the middle of September.

For several months, we have been working hand-in-glove with the Scout Hall Building Committee (SHBC) to develop a plan that would meet the shared goals of the Town and SHBC by facilitating adequate municipal space for our senior center, as well as youth and

civic groups in the community. The discussions have been a true collaboration between the Town and the Scout Hall Building Committee, and I want to thank them for their help on this.

Once construction is completed, the expanded Scout Hall would be used as the Senior Center for the town in the daytime during the week, and by youth and civic groups on nights and weekends. Given that East Windsor's population is ten percent older than that of Hartford County, this project provides the Town a better means by which to deliver services to our senior population, as well as enhance the youth and recreational offerings currently available at the site.

The plan for the project has been designed and engineered and is "shovel-ready". This project will further enhance the ability of the Town to provide needed public services to

senior citizens and the disabled within the community by providing one location where people can register for programs like Renter's Rebate, home heating assistance, Medicare and Medicaid, Senior Farmers' Market Nutrition Program vouchers, SNAP benefits, and more.

Windsor Locks is in the process of a similar undertaking. In their case, they plan to build a 19,000 square foot senior center that would cost approximately \$14 million. In our case, the finished product would be a community center (servicing multiple generations in town), would be approximately 15,000 square feet, and would cost \$5 million. The reason for the cost difference between the two projects is we already own the land and the building, and because most of the infrastructure is already in place. To lessen the amount that may need to be bonded to complete East Windsor's Community Center, the Board of Finance has set aside \$1.2 million from last year's budget surplus. The remaining \$3.8 million in project costs will be sought from federal or state grants, or through local bonding.

This Saturday, the Broad Brook Fire Department will be holding their annual car show at East Windsor Park from 10am to 2pm. The event is open for any cars, trucks or motorcycles. The event is free for spectators, and \$10 entry fee for anyone looking to display a vehicle.

The East Windsor Dog Park will be closed tomorrow and Saturday for fertilization. Sorry for any inconvenience.

The last day for the splash pad for the year will be Monday. It's been a great season, and we're looking forward to having everyone back again next year.

On September 17th, the Board of Assessment Appeals will be holding their motor vehicle appeals hearing beginning at 9:30am. Anyone who feels their motor vehicles were improperly valued may make an appeal on a first come, first served basis. Appellants should bring documentation supporting their vehicular mileage, repair costs, or any other factor that may have led to an improper valuation.

On September 10th, the Lions Club will be holding their third annual golf tournament at Grassmere Country Club. The event is \$100 per person and includes greens fees and a buffet lunch. For additional information or to reserve your foursome, please contact Lion Derek Lussier at 860-758-7793.

Selectmen's Report - September 1, 2022

On August 24, 2022 I attended the Board of Education meeting. It was rather short with not much business conducted.

Superintendent Dr. Patrick Tudryn reported that a High School Business Teacher was not hired for this school year. There were three applicants, but after it was known that funding would be secure, it was too late to fill the position. It was expressed that job postings need to be posted earlier going forward to appeal to viable candidates.

A Financial Update was not given this month, however there was a Memo to Board Members in their packet from the Business Office stating that final checks for the FY22 operating budget will be cut on August 24, 2022 to close out the year and that the ending balance is anticipated to be slightly higher after all the salary grant offsets were completed. In regards to the FY23 Budget, it was also stated that there was a glitch in MUNIS causing the totals to differ from the adopted budget numbers and it took a week for the MUNIS support team to correct the issue and a presentation regarding both budgets will be given at the first September meeting.

It was suggested that the Board consider having a liaison to the PTO and Booster Club to communicate what is going on at their meetings. Going forward there will be a BOE member in attendance.

Monday was the first day of school. Last night was the Broad Brook Elementary School's open house and the Middle School will host their's on Wednesday, September 7, 2022.
