First Selectman Bowsza reported that the East Windsor Board of Selectmen had previously heard a presentation on behalf of the Connecticut Trolley Museum requesting approval of an application to submit a proposal for lighting improvements at the Museum's property. The proposal was presented at a Regular Board of Selectmen's Meeting. When First Selectman Bowsza submitted the request on behalf of the Connecticut Trolley Museum he was told the Town must hold a Public Hearing.

As First Selectman Bowsza is hosting this Public Hearing remotely he requested Deputy First Selectman DeSousa, who is present at the in person meeting, to call the Public Hearing to order.
