Minority representation doesn't require Republican, it just says you can't have a super majority of Democrats. So, maybe someone could reach out to her and tell her that would be an option, if she wanted to at least think about that. Deputy First Selectman DeSousa indicated she didn't agree with that concept of majority representation, Selectman Muska indicated she didn't agree either.
