D. American Rescue Plan Update:

First Selectman Bowsza turned discussion over to Mr. Krivda, consultant for the American Rescue Plan Grant Program

Mr. Krivda reported that since the inception of this funding there has been much discussion with Staff and First Selectman Bowsza regarding the evolution of the program and the language presented in the American Rescue Plan Application which cites the criteria for a grant request submission. Mr. Krivda suggested the intent is for these grants to be an economic multiplier to kick start recovery for small businesses, and to create a dynamic plan for the use of the money.

Mr. Krivda noted the Federal requirements now include a statement identifying the negative impact of COVID 19 on a business, and show how the grant addresses those needs. Mr. Krivda then reviewed East Windsor's current potential grant application, noting the following revisions with the Board: *Eligibility:*

- Definition of a small business Deleting requirement that the business had been in existence for 12 months prior to COVID's impact. (Definition of nonprofit remains the same.)
- Requirement that an applicant must be in good standing regarding tax obligations has been removed.

Mr. Krivda indicated they will be available to work with the applicants to identify their losses and identify the impact of those losses on the business, and then determine how they propose to use the grant to address those losses.

First Selectman Bowsza indicated he has reviewed the proposed revised grant application with the Town Attorney, who has determined the Town is working within the scope of the program. He noted the intent is to post the grant application on the Town's website tomorrow; Mr. Krivda reiterated he will work with applicants as necessary.

First Selectman Bowsza opened discussion to the Board.

Deputy First Selectman DeSousa referenced the deletion of the tax liability. She indicated that while she wants to assist businesses which have been hurt by the pandemic she didn't feel it was fair if someone was several years behind on taxes to benefit from the intent to assist businesses impacted by COVID. First Selectman Bowsza reported the deletion was made at the suggestion of Tax Collector Kratochvil, as she felt they Town had other options to deal with lengthy tax delinquencies. Selectman Baker suggested including language which reserves the right to seek additional information if necessary. Deputy First Selectman DeSousa indicated she agreed with Selectman Baker's suggestion.

First Selectman Bowsza reported that on Monday, July 12, 2021 Senator Blumenthal, Senator Anwar, and Representative John Larson will visit town to announce East Windsor's American Rescue Plan Program. An applicant will have four weeks – until August 9th – to submit an application under grantateastwindsor.com grants@eastwindsorct.com. The intent is to have most of the assistance funding out the door by Labor Day.

First Selectman Bowsza queried the Selectmen for additional discussion; no comments were raised. First Selectman Bowsza requested a motion approving the COVID 19 Eligibility Criteria as amended.

EMERGENCY RELIEF AND STABILIZATION EFFORT (E.R.A.S.E) COVID-19 GRANT Eligibility Criteria

Eligibility

For the purposes of this Grant:

<u>A small business</u> is defined as employing not more than 100 employees and has operations in East Windsor, CT (Examples: a trade name on file with the State of Connecticut or appearance on the Town's Grand List.)

<u>A non-profit</u> entity is defined as an entity with an East Windsor address organized and operated for a collective, public or social benefit (non-profit status may be demonstrated by supplying the organizations CT-990 form or 501(c) incorporation documents.)

- The applicant must be in good standing with the Connecticut Secretary of the State in terms of business/non-profit filings.
- Non-profits must have proof of 501c status.

Application Requirements

- Documentation should be supplied supporting the number of employees before the pandemic and at the time of this application.
- Listing of all federal or state assistance applied for and/or received (i.e., PPP loans, etc.)
- If applicable, dates of closure due to the pandemic need to be provided.
- The applicant must provide a written statement that will identify a need or negative impact of the COVID-19 public health emergency to your organization or business and must identify how your grant request addresses the identified need or negative impact.

Grants will be awarded based upon funds available and the number of applications received for an amount up to and not to exceed \$10,000. All grant awards are subject to conformity with federal requirements.
