First Selectman Bowsza called the April 26, 2023 Special Meeting of the East Windsor Board of Selectmen to Order at 10:33 a.m. in the John Daly, Jr. Meeting Room, Town Hall, 11 Rye Street, Broad Brook, CT 06016.

## 4. NEW BUSINESS:

A. Discuss and accept for CDBG Small Cities Program Application and Program Administration from Housing Development Team, LLC to include Linda Collins, East Windsor Housing Authority and Melissa LaBelle:

First Selectman Bowsza noted this meeting has been called to award the bid for the administration of the Community Development Block Grant to the same consultant the Town has used in the past. This consultant also assisted with the shower conversions at Park Hill. He requested Linda Collins, Executive Director of the East Windsor Housing Authority, to explain what she plans to use the funds for.

Ms. Collins reported the intent of the application is to seek \$2 million in funding to replace the siding on all of the apartment buildings, which are deteriorating, and also to replace the "mini-splits", which provide heat and air conditioning, in all of the apartments. Ms. Collins reported the funding would also enable the Housing Authority to upgrade all the accessible units to make sure they're ADA compliant. The grant would also enable the Housing Authority to access an additional \$4 million through the State for state housing.

Ms. Collins reported the application is seeking a total of \$6 million in total funding, should the projects proposed be considered eligible.

First Selectman Bowsza suggested the Housing Authority is doing a great job at Park Hill. He noted that the Housing Development Team is the only response received to the solicitation, he indicated the Town has worked successfully with them in the past. Melissa LaBelle, Executive Assistant, concurred that she's worked with this firm in the past and found them very easy to work with. Ms. LaBelle concurred that this consultant was the only bidder. She noted the project has a very short deadline to apply for the funding, this firm is willing to work with the Town to seek this funding. First Selectman Bowsza noted the letter of intent must be submitted by April 30<sup>th</sup>, 2023.

First Selectman Bowsza asked if any members of the Board had any questions or comments; no one raised any questions. First Selectman Bowsza requested a motion to award the bid to Housing Development Team LLC for the projects outlined by Ms. Collins.
