The members then discussed the CIP policy and asked that it be updated so that we have a process in place for things that are not in the budget, supplemental appropriations and/or for capital items.

MOTION: To approve in the CIP Committee a recommendation for bonding of \$5,234,930 for the Broad Brook Dam Repair Project, Middle School Roof Replacement project and for the road projects as determined by the Pavement Management Plan and the Public Works Director and recommend it to Board of Selectmen, Board of Finance, and Planning and Zoning Commission for bonding.
