NEW BUSINESS/a. Status of Follow-on CRC startup and calendar:

Co-Chairman Matthews reported that the Board of Selectmen agreed at their last meeting to create a Charter Revision Commission (CRC), but have not yet populated it.

Co-Chairman Matthews referenced a list of charges discussed at the BOS Meeting While the CRSC had considered splitting budget approval into Town and Board of Education budgets Co-Chairman Matthews noted Selectman Hoffman had discussed including line item approvals at referendum for larger budget expenditures, such as the Police Department, Parks and Recreation, Board of Education, Public Works, etc. The CRSC then discussed consolidation of services, prioritization of funding, and regionalization,

The CRSC noted one of the BOS's charges to the CRC is to create a position to research information to assist the Town find ways to cost effectively provide services to residents. The CRSC discussed this position in relation to a Town Administrator, Town Manager, or Chief Financial Officer.

NEW BUSINESS/b. Discuss recent Referendum, voter participation and ways to improve it:

The CRSC discussed the percentage of voter participation in East Windsor vs other towns, and then considered various methods of communicating the budget information to the residents. This year the Town provided a flyer prepared by the Treasurer summarizing the budget requests; the BOE posted yard signage urging people to vote.

NEW BUSINESS/c. Discussion of Checks and Balances for every Position, Board, Committee, etc.:

The CRSC discussed checks and balances for department funding requests. They also considered the effect of elected vs. appointed Board and Commission membership.

2018 East Windsor Charter Study Commission

Review of current Hebron Charter ~ May 14, 2018

Highlights:

- 1. Form of Government ~ Selectman (Council) /Town Manager
 - a. BOS (Council) is legislative body except as provided in Chapter 3 when Town Meeting is legislative body.
 - b. Town Meeting relinquishes considerable authority to BOS
 - Ordinances are approved by four affirmative votes of BOS after at least one public hearing.
 - 1. Referendum can override some actions of BOS with petition of 2% of electors (within 20 days)
 - Special Town meetings on some_items can be called by Petitioning with 2% signatures, vote at meeting requires quorum of 25 voters.
 - a. Supplemental appropriations which exceed 1% of budget
 - i. BOF approves supplements up to 1% of bidget
 - b. Create or abolish Town agencies
 - c. Annual Budget approved by Referendum.
 - i. No limit to # of Referendums to approve Budget.
- 2. BOS ~ Five Selectmen. All are four year terms.
 - a. Town Manager is CEO and CAO
 - i. There is a Town manager who is hired and fired by BOS with 4 affirmative votes.
 - 1. Responsible to BOS.
 - 2. Appoints Town Attorney to two year term with BOS approval.
 - 3. Prepares Town Government budget and presents to BOS.
 - 4. Town manager Administers, Supervises, and Researches He is Personnel officer handling labor matters.
- 3. Other Elected positions, all four year terms (not a complete list)
 - a. BOE ~ 7 members
 - b. BOF ~ 5 members
 - c. P&Z~5 members
 - d. Town Clerk
 - e. Regional BOE per CGS 10-46

 Board of Finance with input from BOS and BOE is responsible for preparing, and monitoring the Annual Town Budget. They will submit a proposed Annual Budget to the Annual Referendum in May.

5. Other:

- a. Hebron uses Resident State Troopers and Constables.
- b. The Approved Budget fixes every line item. Intradepartmental transfers can be approved by: Town Manager up to \$2000, By BOS up to \$10,000, and by the BOF when greater than \$10,000.
- c. Interdepartmental transfer can be made after April 1st by the BOF.

(All the forgoing is my interpretation of the most recent Hebron Charter.
