STATUS REPORTS:

Wetlands Agent Whitten reported on the following issues:

- Contacted the developer of Newberry Village of complaints regarding mud leaving the site and spreading out onto Newberry Road due to the rain today. Site inspection also made to confirm complaints.
- Site inspection of work being done at 4 New Park Road. Wetlands Agent Whitten reported wetlands are located to the rear of this parcel. The site looks great; the applicant has done a stellar job on this project.

VIOLATIONS:

Inland Wetlands Agent Whitten advised the Commission she had received a complaint from a neighbor of the owners of property at 177 Wells Road. Wetlands Agent Whitten reported the entire site is located within wetlands. The property owners are advertising for fill; they have already received several loads of material which is being deposited within the wetlands. Wetlands Agent Whitten has left a message with the homeowners to contact her. She is concerned that they will spread out the fill already received. Her intent is to send a letter advising the homeowners they need to remove the fill already acquired, and advise them to come before this Board for a permit.

The Commission concurred with Wetlands Agent Whitten's proposal for additional phone contact followed by a letter of advisement.
