<u>DISCUSSION:</u> The Commission considered if this application should be heard under a Public Hearing. They noted there are several abutting properties but most are commercial uses. Chairman Baker acknowledged Mr. Crane's presence if the anyone had questions. Mr. Crane suggested he felt the application was pretty straight forward; the ditch is what it is but currently is overgrown with weeds and accumulates papers. He is also proposing to connect to the sewer system. Mr. Crane joined the Board to note a corner of wetlands which contains several large trees, perhaps half of which are dead and some of which overhang abutting properties. He would also like to take down the dead trees. Chairman Baker suggested he would like to visit the property. Acting Wetlands Agent Higley indicated she has an inspection on her schedule as well. She would like to review the trees mentioned by Mr. Crane; she noted removal of trees often impacts wetlands ability to filter run off. Mr. Crane offered to meet with anyone wishing to view the property.

The consensus of the Commission was that this application does NOT need to be heard via a Public Hearing.

## **AGENT DECISIONS/REPORT:**

Acting Wetlands Agent Higley reported she has visited Newberry Village on several occasions. She has received complaints from residents regarding removal of trees which they feel are dead. She has met with one resident and allowed removal of two trees while requiring the third tree to remain. She has also met with a representative from the homeowners association who has agreed to advise Newberry Village residents of the need to bring requests regarding trees to the Association; permission must be received from the Newberry Village Board of Directors and the Town.

Chairman Baker and Commissioner Osborn recalled the lengthy/detailed discussion during approval of this project regarding the need to preserve the wetlands and vernal pools. They also noted the property encompassing Newberry Village is heavily impacted by a Conservation Easement. Discussion followed regarding the specifics of the landscaping plan for this project. Commissioner Osborn suggested a copy of the map reflecting the Conservation Easement be posted on the Homeowners Association bulletin board.

## **STATUS REPORTS:**

Chairman Baker questioned the status of a request from a Scantic Road resident regarding placement of a shed near a slope? Acting Wetlands Agent Higley reported the resident had questioned placement of a container; the suggested location was unfavorable to the resident.
