# 5. POSSIBLE APPOINTMENT OF INVESTMENT ADVISOR FROM RFP PROCESS DECISION:

After a lengthy discussion and a poll of the Board they decided they were ready to make an informed decision and choose an investment advisor.

#### 6. NEW BUSINESS:

#### A. Pension Fund Update-Webster Bank:

Robert Lebreux and Robert Maglio came and gave a lengthy update on the pension plan. They explained that they would basically stick with the same strategy as they have been using. They said that they believe 60/40 split is the way to go. To view their presentation it is available in the Treasurer's office. They said that December was very bad for the market. The beginning market value was a little over \$25 million after the contributions, withdrawals and everything else. They ended with a -3.71% return, finishing with \$24,287,000. As of this meeting he stated that is already up to \$24,783,000. David King asked them if they could include a quilt chart and the "year end thing" with their next presentation.
