Chairman Kowalski identified wording that could be misinterpreted. Moving forward, language regarding special permits, signage, event hosting, and others, could be reworded for easier understanding and application. In most cases, these rules are not enforced until there is a complaint.

The POCD survey has, so far, garnered 68 responses. The survey is available at East Windsor High School, and May 1 a QR code will be released. There will be a future business survey developed.
