REGULAR MEETING: December 12, 2018

1. CALL MEETING TO ORDER AND ATTENDANCE:

Chief DeMarco said he thought it was the yearly fee and its used for travel for various reasons to include conducting background checks and investigations.

Chief DeMarco covered the FY 19/20 police department budget line by line. Commissioner Burns stated she believes the vehicles should be in the budget and not under Capital Improvements. Commissioner Long stated we need more tasers. Chairman Leach agreed and said firearms should be added, too. A discussion ensued.

MOTION made by Commissioner Filipone to approve the budget to include the changes to the Uniforms & Equipment for the purpose of additional firearms and tasers.
