**DISCUSSION:** Commissioner Filipone asked what the charge for \$5,663.17 was for. Chief DeMarco explained it's for the Power DMS annual fee for the accreditation management software. Commissioner Filipone asked Chief DeMarco if he could put together a list of commonly used vendors. Chief DeMarco said they could put together a preferred vendor list for them.

# 6. TRAFFIC AUTHORITY:

Chairman Leach discussed the traffic study that was completed for Depot Street and Emily Road. Commissioner Filipone concurs with the study and added that the signs that are not legally marked should be fixed; the Commissioners agreed. Chief DeMarco will also keep the area on the Selective Traffic Enforcement Program (STEP) and repair necessary signs. No action is required from the Commission. A discussion ensued.

Chief DeMarco passed out a letter to the Commissioners he received from the DCF Solnit Center. The letter asked for the police to send a request to the DOT to get school zone advisory signs (non-enforceable). The Commissioners agree to sending the letter. A discussion ensued.

### 8. COMMUNICATIONS:

Chairman Leach received an anonymous letter in the Town Hall mailbox with no return address on the envelope. An article about a former South Windsor Police Chief was in the envelope and a letter asking why the police department doesn't publish a daily log. Chief DeMarco explained they stopped the daily log when personal, private information was accidentally released which was very costly to the town. The law does not require daily logs to be published online and the risk of liability is too high. The police department follows the law and processes requests as they come in to the department. The department recently acquired a new computer software system and he will check to see if the system handles this type of request any differently and report back to the Commissioners.

# 9. MONTHLY REPORTS:

Commissioner Hayes stated there are people crossing the street at Broad Brook school and not using the cross-walks. It's very hard to see them, especially at night and they should really be using the cross-walks that are in place.
