Commissioner Burns stated that someone made a comment that no one serving on the police commission has knowledge of police work. Chairman Leach stated "well, that's just false" and went on to state the police commission is a non-political commission and to eliminate them would be detrimental to the police department and a disservice to the community. A discussion ensued.
