# **REGULAR MEETING: May 10, 2017**

# 1. CALL MEETING TO ORDER AND ATTENDANCE:

Meeting was called to order at 7:00pm by Chairman Strempfer. Commissioners Filipone, Leach, Hayes and Pippin were present. Also present were Chief Edward DeMarco Jr. and Deputy Chief Roger Hart. Present in the audience were First Selectman Robert Maynard, Lieutenant Poliquin, and Sergeant Reimer.

#### 2. ADDED AGENDA ITEMS:

#### **3. PREVIOUS MEETING MINUTES:**

The minutes from the April 12, 2017, regular meeting were reviewed by all commission members. **MOTION** made by Commissioner Leach to accept the regular meeting minutes of 04/12/2017.

#### 4. BUDGET AND EXPENDITURES:

**A) Police Department** – **Monthly Billing: MOTION** made by Commissioner Hayes to accept the monthly billing as submitted, to include Animal Control, in the total amount of \$5,835.65.

**B)** Police Department – Financial Statement: MOTION made by Commissioner Leach to approve the monthly financial statements, through 5/5/17, including Animal Control.

**DISCUSSION:** Commissioner Filipone asked if there were any budget issues coming up. Deputy Chief Hart explained the variable overtime line is low, but reimbursements of approximately \$15,000 from the OUI grant, distracted driving grant and the expenditures for the recent plane crash should be coming in. They will request movement of funds from the officer line to the variable overtime line if necessary.

## 5. UNFINISHED BUSINESS:

## 6. TRAFFIC AUTHORITY:

Chief DeMarco stated the traffic gear is in place at Park Hill and the study should be finished this Friday. Results will be given at the next police commission meeting.

In regards to the Showcase Cinema traffic light, Deputy Chief Hart explained the state agreed with the LTA to keep the traffic light in place. The issue is that someone needs to pay the bill. They are still waiting to hear back from Wal-Mart to see if they will pay the bill; Chief DeMarco will contact them again before the Tuesday Board of Selectmen meeting. If Wal-Mart does not agree to pay, the Town of East Windsor needs to decide if they will. First Selectman Maynard will put this on the agenda at the Tuesday Board of Selectmen meeting and get a decision. The cost is \$11 up to \$15 per month for the cost of the light. If the light requires maintenance, the state will only pay up to \$500 and the rest of the cost will be assumed by whoever is paying for the light.

Commissioner Filipone questioned if the commission can direct Calamar to put in a sidewalk. Chief DeMarco explained Calamar has agreed to the DOT and LTA suggestion for a sidewalk. In addition, Calamar has submitted the plans and would like concurrence.

#### 7. NEW BUSINESS:

Sgt. Reimer explained he believes there is a pay issue with Officer Mitchell that is due to the language in the union contract in one particular paragraph. He believes the language used in

the contract should allow Officer Mitchell to count his one year of police service prior to coming to East Windsor in order to be paid at the next level of the pay scale. Chairman Tom Strempfer questioned if officers prior to Officer Mitchell had this issue to understand past practice. Sgt. Reimer explained the other officers were paid at the years of service with East Windsor Police, not total years of police service, and had never brought up any issues with the contract language or pay scale levels. Sgt. Reimer proposes they pay Officer Mitchell on the next pay scale and count his one year of service prior to coming to East Windsor. He would then agree to change the language in the contract so in the future it would be clear that only years of service at East Windsor would count and not all years of police service regardless of where that police service occurred. If the police commission does not accept his proposal he will go through the union. A lengthy discussion ensued.

**MOTION** made by Commissioner Leach to enter executive session at 7:45 pm to discuss pay issue.
