REGULAR MEETING: May 11, 2016

#### 1. CALL MEETING TO ORDER AND ATTENDANCE:

#### 7. NEW BUSINESS:

Chief DeMarco presented a public safety software solution for the East Windsor Police Department. NexGen offers a comprehensive and interactive computer software system containing modules that can be divided into three primary functional areas: Computer-Aided Dispatch, Records Management System, and Scheduling. This empowers police departments to optimize performance, increase efficiency, and respond. The technology centralizes the database, which enables data to be used continuously throughout the application. The central database improves workflow, enhances department automation, and promotes simplicity by

reducing data entry and streamlining intelligence. They also know how to integrate with FBI, NCIC, and NIBRS standards. Chief DeMarco passed out packets regarding NexGen and a lengthy discussion ensued.

Chairman Strempfer and Commissioner Filipone asked about the cost of the software system. Chief DeMarco and Deputy Chief Hart explained the initial cost would be approximately \$173,000. After the initial cost, the yearly maintenance fee would be significantly lower than what we are currently paying for our older IMC system which was purchased in 1995. The money they are seeking will come from the Town's General Fund that the town needs to spend down in order for the bond rating to go up.

**MOTION** made by Commissioner Filipone to authorize Chief DeMarco to proceed with the purchase of the NexGen system.
