#### 6. TRAFFIC AUTHORITY:

Chief DeMarco stated they have not heard back from the state on the Rt. 140 request. He will try to contact them again in a month or two, but doesn't think the state will grant the request based on the level of accidents there. Deputy Chief Hart went on to explain if the state is going to consider a change to an intersection, they look for a level of accidents that occur and the threshold is five in a twelve month period and rear-end type accidents.

#### 7. NEW BUSINESS:

Chairman Leach said the Charter Study Committee made recommendations to the Board of Selectman and he didn't hear anything on the Police Commission even though they have talked extensively about the Police Commission at their meetings including eliminating the Police Commission. Commissioner Burns stated at the last meeting of the Charter Study Committee they discussed clarifying the role of the Police Commission. She's not sure if they revised anything with the Board. She stated there's only one line in the charter and they feel it should be more defined. Chairman Leach then stated the statute defines it. He went on to say he knows there had been discussion in the Charter Study Committee about the contract negotiations and he thinks they want all contract negotiations falling within the budget year, but he wasn't sure. Commissioner Burns believes they don't want it to be within the budget year, but in the reign of the First Selectman; being done with the current Selectman, not started and ended with another. She should know at the next meeting. Chairman Leach stated the Board of Selectman is appointing a Charter Revision Commission next week and he put his name in.

#### 8. COMMUNICATIONS:

Chairman Leach congratulated the group in getting the budget passed. He is changing the email address on the town website for the Police Commission so it will be accessible.

#### 9. MONTHLY REPORTS:

Commissioner Filipone asked about the two vacant police officer positions. Chief DeMarco stated they will be doing a full advertisement within the next month to test in June. A discussion ensued.
