REGULAR MEETING: August 10, 2016

1. CALL MEETING TO ORDER AND ATTENDANCE:

Meeting was called to order at 7:00pm by Chairman Stremper. Commissioners Filipone, Leach, Hayes, and Pippin were present. Also present was Chief Edward DeMarco Jr. and Deputy Chief Hart. Candidates for Police Officer, Amber Flagg and Kasey Gonsalves, were present in the audience. At 7:15pm Board of Finance member Mr. Steve Smith arrived.

2. ADDED AGENDA ITEMS:

Agenda #11, Executive Session: Interview for Police Officer.

3. PREVIOUS MEETING MINUTES:

The minutes from the July 13, 2016, regular meeting were reviewed by all commission members. **MOTION** made by Commissioner Hayes to accept the regular meeting minutes of 07/13/2016.

ALL THOSE VOTING, VOTE IN FAVOR. MOTION CARRIED.

The minutes from the July 28, 2016, special meeting were reviewed by all commission members. **MOTION** made by Commissioner Leach to accept the special meeting minutes of 07/28/2016.

4. BUDGET AND EXPENDITURES:

A) Police Department – Monthly Billing: **MOTION** made by Commissioner Filipone to accept the monthly billing as submitted, including Animal Control, in the total amount of \$7,214.80.

DISCUSSION: Commissioner Filipone asked about the Professional Services fees. Chief DeMarco explained they are annual contract/maintenance fees for the Verint Audio Log used

in Dispatch and the mandatory iRecord video recording component used in higher felony interviews.

Monthly Billing: MOTION made by Commissioner Leach to accept the monthly billing from last fiscal year 2015/2016.

DISCUSSION: Deputy Chief Hart explained these are bills from 2015/2016 that were expected and came in after the fiscal year close. He also explained it looks like we gave back \$14,000 out of the training line, but that money was used and came out of the variable overtime line. The Chief's Administrative Assistant was on a temporary leave of absence for an extended period of time. This absence left payroll, accounts payable, and other tasks in the hands of other employees. To make the payroll process easier, Deputy Chief Hart had communicated with the Treasurer's office advising them that we would pay all overtime out of the variable overtime line and then we would reconcile at the end of the year.

ABSTAINED: Commissioner Hayes. Commissioner Hayes recused himself from voting and expressed no opinion during the interview process due to his acquaintance with a relative of the candidate.

MOTION made by Commissioner Leach to authorize Chief DeMarco to make a conditional offer of employment to Police Officer candidate Kasey Gonsalves only in the event a new hire fails to successfully complete requirements of employment or in the event a currently employed officer retires.
