

TOWN OF EAST WINDSOR

Ordinance 23-03

The following ordinance was adopted at a Special Town Meeting duly warned and held on June 28 2023.

"ORDINANCE CONCERNING YOUTH SERVICES ADVISORY BOARD"

WHEREAS, the Town of East Windsor seeks to create a Youth Services Advisory Board to govern the Town's Youth Services Bureau pursuant to Conn. Gen. Stat. § 10-19m and Regulations of Conn. State Agencies § 10-19m-2;

NOW, THEREFORE BE IT ORDERED by the legislative body of the Town of East Windsor in a Special Town Meeting duly assembled that, pursuant to the Charter of the Town of East Windsor, the following Ordinance is adopted:

SECTION 1. ESTABLISHMENT.

Pursuant to Regs. Conn. State Agencies § 10-19m-2, the Town of East Windsor's Youth Services Bureau shall be governed by a Youth Services Advisory Board comprised of a maximum number of seven (7) members, each of whom shall be appointed by the Board of Selectmen.

SECTION 2. MEMBERSHIP.

The Youth Services Advisory Board shall be comprised of representatives from the Town who are committed to serving the youth of the Town of East Windsor. Members of the Board shall include:

1. A member of the Board of Selectmen who shall serve as Chair.
2. The Director of Youth Services, who shall be an ex-officio member if not a Town resident, or an official member if he/she is a Town resident.
3. Not less than one member from the Town of East Windsor Police Department, who shall be an ex-officio member if not a Town resident, or an official member if he/she is a Town resident.
4. Not less than one member who is under 21 years of age.
5. Not less than one member who is a representative of the school system, who shall be an ex-officio member if not a Town resident, or an official member if he/she is a Town resident.
6. Not less than one member who is a representative of a private youth serving agency.

At least one-third of the total membership shall be comprised of individuals who receive less than 50% of their income from delivering services to youth.

All members of the Youth Services Advisory Board shall reside within the Town of East Windsor, except as noted above.

SECTION 3. TERMS

Members of the Youth Services Advisory Board shall serve a term of 3 years. Vacancies occurring on the Board shall be filled by the Board of Selectmen in accordance with the provisions of the Town Charter.

SECTION 4. DUTIES.

The Youth Services Advisory Board shall be responsible for advising and making recommendations on overall policy and program direction for the Town's Youth Services Bureau whose mission shall be as delineated in Conn. Gen. Stat. § 10-19m(b).

SECTION 5. NO CONFLICT WITH STATE STATUTES.


This Ordinance shall not be construed to conflict with any local or state statute, rule or regulation.

Said Ordinance shall become effective fifteen (15) days from publication thereof (July 13, 2023).
