6. REPORT OF THE FIRE CHIEF:

Chief Tom Arcari reported on the following items:

- The Broad Brook Fire Department responded to 67 calls for the previous month.
- The Board of Selectmen voted on June 1st to purchase 8 infra-red thermal cameras for each of the Town's two Fire Departments. The purchase is being proposed under remaining ARPA Funding available to the Town.

7. <u>UPDATE ON STATUS OF VEHICLE REPLACEMENT:</u>

Chief Arcari reported everything remains on schedule with the vehicle replacement.

8. REPORT FROM FIRE MARSHAL AUSTIN:

Fire Marshal Austin reported he's been on vacation so he has nothing to report regarding inspections for this side of town.

He noted he recently drove by the Plantation Road Solar Project. It's a very large facility which will have its own road designation.

9. STATUS OF TOWN OF EAST WINDSOR BROAD BROOK FIRE DEPARTMENT 2022 – 2023 BUDGET:

Chief Arcari reported the current budget should close out without any surprises. Commissioner Loos questioned the recent expenditure of \$8,000.00 and \$40,000.00; Chief Arcari reported the expenditure was for extraction tools for the new truck.
