Vice Chairman Macsata opened discussion on the CIP (Capital Improvement Projects) items, noting it's important to let the people know the funding is showing in two budgets when it moves on to the Board of Finance. First Selectman Bowsza indicated there is still money in for the truck after the second round. The funding for the truck will be removed after the CIP Budget is approved.
