## ABOUT EAST WINDSOR

East Windsor is located midway between Hartford, Connecticut and Springfield, Massachusetts. The Town lies on the east bank of the Connecticut River and is bordered by the Towns of Enfield on the north, Ellington on the east, South Windsor on the south, and Windsor on the west. Two major highways, U.S. 5 and I-91, traverse the western part of Town. Interstate 84 is within ten minutes for easy access to New York and Boston. Regular public transportation is provided by Connecticut Transit, Dattco Bus and Dial-a-Ride. Bradley International Airport is ten minutes away.

East Windsor's strategic location offers opportunities for business and industry to grow. A recently updated plan of development and ongoing sewer expansion provides the town with a blueprint for balanced growth and the ability to sustain a favorable tax rate.

Located within thirty minutes of a population base of over one million, and the beneficiary of two direct highway exits off Interstate 91, East Windsor offers businesses an array of opportunities for commercial development in a well-established business park off of U.S. 5. The Route 5 corridor is also home to a host of restaurants, hotels and stores that give business travelers an excellent location from which to work.

The First Selectman is the chief administrative and executive officer, directly responsible to the Board of Selectmen for the administration of all Town agencies and enforcement of all laws and ordinances governing the Town. The Treasurer is responsible for the accounting and reporting of all financial transactions, investment of Town funds and is the Town pension plan administrator.

This is what I see: the workers in all departments are dedicated, hard working people who are committed to serve the Town and make East Windsor the best it can be. East Windsor is fortunate to have such good people working each day to meet the needs of East Windsor.



Also, I recognize and thank the board and commission members who volunteer their time to bring life to the Town, help chart East Windsor's course and ensure tasks are done correctly. Special recognition should be given to the Permanent Building Committee and Department of Public Works who contributed substantially to the successful completion of the Broad Brook Elementary School modular project and to the volunteer fire fighters who enable the Town to meet a critical need.

The Town is in good financial shape. We have an excellent rating (Aa2) which helped secure a good interest rate on the \$5,740,000.00 bonding issue that will fund roads, dam repairs and the modular project. The Assessor's Department continues to compile the Grand List by discovering, listing and valuing property and administering exemption and tax relief programs as required by applicable state and federal law or local ordinances.

In accordance with Connecticut General Statutes, the last Real Estate Revaluation was completed for the October 1, 2012 Grand List and the next Revaluation is scheduled for October 1, 2017 and the field work is in progress. Motor Vehicles and Personal Property are revalued annually. The Grand List of October 1, 2015 was completed on January 31, 2016. The net taxable Grand List as reported to the State of Connecticut on April 11, 2016 was \$961,944,790.

The assessment total for the top ten taxpayers (including real estate, personal property and motor vehicles) on the October 1, 2014 Grand List was 143,530,870, representing 13.25% of the Gross Grand List.

The Human Services Department is an essential part of the community, providing assistance with social, emotional, and economic needs while helping clients to attain self-sufficiency and maintain economic well-being. Our department helps clients access assistance with their energy needs through the Connecticut Energy Assistance Program and Operation Fuel. This past year we processed 406 applications providing a total of \$211,162 in assistance. We are also responsible for distributing Farmer's Market Coupons to seniors and this year 70 seniors received coupons for a total market cash value of \$1,260. Another way that we help our seniors and individuals with disabilities is to process Renter's Rebate applications. This year we processed 174 applications which resulted in \$93,260 worth of benefits being paid.



We also help our families with our in-house "Back to School" program. Backpacks, school supplies, and shoe vouchers were provided to 110 children. The holidays are also paid special attention to as we partnered with the VNA and Five Corner Cupboard to provide 416 baskets of holiday food. Our partners in the community helped us to provide holiday gifts to 160 children.

The Parks and Recreation Department is an active and proud member of the East Windsor community. This year we featured a new partnership with the East Windsor PTO to host a community Halloween event. This event was a huge success with over 250 kids in attendance and our very own Superintendent handing out candy. The families had a great time and we look forward to this year's event on October 27<sup>th</sup>. The East Windsor Wellness Coalition which is run by the Parks and Recreation Department received the yearly ERASE grant which was used throughout the Community to educate and provide services to allow families to make wise and healthy decisions when it comes to drugs and alcohol. We were also awarded money to purchase a prescription take back box which is now housed at the East Windsor Police Department for 24-hour drop offs of unused prescriptions. Thank you to ERASE for their generous donation. The Parks and Recreation Department was awarded money in the Capital Improvement Line to add ADA compliant bathrooms to both Osborn Field and East Windsor Park. That construction will start in the Fall of 2016. East Windsor welcomed over 2,000 nonresident visitors to our park this year. As well as hosted five corporate rentals to the parks pavilion. Resident usage was down and the Parks and Recreation Commission is considering eliminating the ban on non-residents fully for the Summer of 2017. Our dance program hosted another great recital in May with 57 dancers participating this year. The newly formed Breakfast with the Easter Bunny cosponsored by the East Windsor Rotary Club was a great hit with almost 150 breakfasts being served and some great photos being taken with Peter Cottontail! Finally, our Summer Fun Camp Program hosted 80 campers and 12 Counselors in Training this year to cap off a successful year in Parks and Recreation. We can't wait to see what is in store for us in the upcoming year. The Parks and Recreation Commission meets every other month on the second Monday of the month at 6 p.m. at the recreation office inside of East Windsor High School. The Department of Planning and Development provides staff assistance to the Planning and Zoning Commission (PZC), Zoning Board of Appeals (ZBA), Inland Wetlands and Watercourses Agency (IWWA), the Conservation Commission (CC), Agricultural Commissions (AC), and Economic Development Commission (EDC). This includes a full range of administrative, clerical, technical and policy services to the land use boards, while meeting the challenging and changing goals and demands of the community.

The Department continues to work with the public for all land use questions and permits, with an open door policy. We endeavor to resolve any issues or conflicts with a client's application before submittal, saving the client time and money. Preliminary development discussions are encouraged and helpful to all stakeholders. In an effort to serve the public in a more efficient manner, the Town purchased a permitting software program to integrate the process with all related departments. Implementation and integration became a priority of the town. Staff was instrumental in helping clients obtain approvals for a fitness center, church, youth center, numerous business expansions, 2 gas stations, a 69 lot subdivision, and some smaller subdivisions, all helping to improve our tax base.

As part of our Plan of Conservation & Development 2016, workshops were held focusing on Route 5, and Warehouse Point Village, attempting to decipher a path to sustainable redevelopment. This will be an important component when the high speed commuter rail is put into service across the Connecticut River.

The Warehouse Point Library, an integral part of the Town of East Windsor, supports all people in its diverse and culturally changing community, in their enjoyment of reading and pursuit of life-long learning through its books, services, programming and friendly staff. Besides a collection of over 40,000 items that includes, books, magazines, DVDs, books on cd, downloadable audiobooks, downloadable e-books, the library offers a variety of services and programs to the community. Almost 32,000 visits were made to the library, both physically and electronically last year to borrow over 40,000 items from the collection; use our computers; access our databases; and to attend library programs. Over 1,700 children attended the 114 programs the library presented last year while over 200 attended our adult programs ranging from book discussions to discussions on the television series The Twilight Zone and Star Trek.

The library's annual fund drive is the only source of money for the library's collection development. Fund drive monies are used to purchase books, DVDs, audiobooks and magazines for the adult, young adult and children's collection. The Library Board and staff want to thank those who donated generously to fund the library's commitment to expanding its various collections.

The East Windsor Senior Center continues to meet the needs of our seniors in a variety of ways. The Senior Center provides several benefits such as; socialization and trips, monthly entertainment, educational programs, a nutrition program, exercise programs, arts and crafts, and senior outreach. We also screen for eligibility of basic needs programs, provide information and referral, and review Medicare Part D plans. This year we have had great success with our trips off grounds from the Senior Center. We took a total of 48 trips with 1,030 duplicated seniors participating! We have had a lot of fun times. Our fitness and yoga classes also continue to be very popular and we average between 15-20 participants in each class weekly. We also added four new in-house programs to our monthly calendar. This year we hosted our first annual health fair where flu shots were provided as well as other health services such as sugar, blood pressure, hearing, and balance screenings. There were also several local businesses and services present to provide information to our seniors. We look forward to providing this annually. This year we have also developed strong partnerships with the schools and local businesses.

# Senior Center



The East Windsor Senior Transportation Program strives to supplement the transportation needs of our town's senior citizens age 60 and older as well as adults over the age of 18 that are on Social Security Disability. Transportation is an essential program as many seniors in our community are unable to drive themselves. We strive to provide a comfortable and safe service. All of our vehicles are equipped with handicap lifts and are driven by friendly, trained, and licensed drivers. We provide pre-scheduled transportation to medical appointments, grocery stores, banks, pharmacies, and to the Food Pantry and Mobile Foodshare. We also provide daily transportation to the Senior Center for lunch and programs and activities. Our ridership has increased significantly this past year offering the following two way trips; 1,264 medical appointments, 3,128 nutritional rides, 2,152 rides for grocery shopping, 2,756 rides for other personal needs, and 1,444 for social activities. Total rides provided was 10,744 round trip rides which was 1,972 more than last year! We are very happy to note that our seniors and adults with disabilities are increasingly taking advantage of transportation services to meet their needs.

# Senior Transportation



The East Windsor Senior Nutrition Program continues to offer a warm, friendly, safe environment for our seniors to congregate, socialize, and enjoy a well-balanced, nutritious lunch. Fresh meals are delivered daily to our Community Café by the Community Renewal Team of Hartford. Our daily hot meal is offered to seniors over the age of 60 at a suggested donation of \$2.50. When seniors join us for lunch they are not only getting a great meal, but they have the opportunity to socialize with friends and also participate in programs at the Senior Center before or after lunch. We are very excited that this year we served 5,447 meals! Meals on Wheels is also a very important part of the Senior Nutrition Program. Meals On Wheels is offered to those seniors that are homebound and cannot shop for or prepare their own meals. Two meals are delivered daily by our dedicated and friendly volunteers. This year our volunteers delivered 4,566 meals! We are very fortunate to have dedicated volunteers. Our Nutrition Site Manager also hosts a monthly program where she discusses one specific food and it's use in history, nutritional value, and a recipe for that food item. We have also been working on updating tables and chairs.

#### SENIOR CENTER CAFE

The Senior Center administers the [CRT Elderly Nutrition Program](#) offering meals-on-wheels and congregate meals in senior centers and community centers. The purpose of this program is to provide seniors with well-balanced and tasty meals. As well as foster a sense of community and encourage socialization.

#### MEALS ON WHEELS

Two meals a day are delivered five days a week (weekend meals are delivered on Friday) 52 weeks a year to homebound elderly residents. Each delivery consists of one hot lunch and one cold bag supper. Meals are prepared according to a diet order from the client's physician. Cut up, ground and most therapeutic diets are available.

Although meals are provided at no charge, clients are asked to consider making a donation of \$ 5.00 per day or \$ 2.50 per meal.

The office of Town Clerk is responsible for administering the Connecticut General Statutes in the areas of records management, vital statistics (births, deaths & marriages), land records, maps, elections, sporting licenses, dog licenses, liquor permits, Veteran's discharges and notary certificates. In addition, our daily duties include maintaining Town Clerk's web page, the town website calendar and list of town ordinances. We also post the minutes and agendas for the Boards and Commissions on the town website. We continue to scan more of the older land record documents into our computer for people searching the land records. We now have a Connecticut Vital Records System (ConnVRS), from the State of CT. This program allows us to print birth records off of the computer for any town in the State, starting with births occurring after January 1, 2016. This year my part-time Assistant, Mary Higgins retired. I want to thank her for her dedication and hard work through all these years. She will be greatly missed by many people. I want to also thank my full time Assistant, Lynn Lemieux for all her hard work & continuing dedication to this office.

This has been a very busy year in the Treasurer's Office. Assistant Treasurer Gayle Carolus and I passed five rigorous CPFO Certification exams and we have both obtained Certified Public Finance Officer designations. The CPFO certification is overseen by the Government Finance Officer's Association and administered by Radford University. Many thanks to Assistant Treasurer Kim Scavotto for her support and holding down the fort while we attended the training and exams.

After upgrading our accounting software last year, we again took on the challenge of instituting significant changes to increase efficiency and save money. We instituted a paperless payroll system and switched payroll providers, saving the Town thousands of dollars each year. We also were instrumental in switching to a new health insurance provider for Town Employees. This change was not undertaken lightly, but the overall savings to the Town were substantial.

On a lighter note, the Treasurer and Tax Office staff worked together on an entry in the annual Scarecrow contest sponsored by the Park and Rec department and we were thrilled to win first prize!

The staff of the East Windsor Water Pollution Control Facility is pleased to report on the goals and objectives of the WPCA. In addition to the daily operation and maintenance of the treatment plant and 10 sewage pump stations, staff maintains the 25 plus miles of sewers and force mains. The Route 5 sewage pump station was a main focus this year, receiving new check valves, inlet and discharge valves, along with a force main isolation valve. A new underground electrical service was installed with a new standby generator and transfer switch. The site was stabilized with a retaining wall. We continue to focus on rebuilding and replacement of critical equipment. Variable frequency drives have been installed on much of the rotating equipment. Waste Sludge pumps were retrofitted with new non clog impellers. We received a FEMA Grant to assist us with our ongoing program of providing remote communication to our offsite sewage pump stations. The Digester brick work was repointed and the pump house received a new roof. A new electrical panel along with new wiring and floats were installed at Scout Hall Pump Station. We began the replacement of the Area Control Panels (ACP's) that contain all the electrical components that send signals and logic to the various equipment in the facility.

The Public Works/Engineering Department consists of 6 Highway Maintainers, 1 Facilities/Inspections Maintainer, 1 Parks & Grounds Maintainer, 1 Working Foreman, 1 Administrative Assistant and a Director of Public Works/Town Engineer/Tree Warden. The Department is responsible for the maintenance of approximately 70 miles of roads, including storm drainage, curbs, waterways, roadside mowing, etc. We are also responsible for the maintenance of the grounds at all Town parks and fields, around all Town owned buildings, including Town schools and their playing fields, as well as, facilities maintenance for all Town owned buildings. We are on call 24/7 to the East Windsor Police Department and the Broad Brook and Warehouse Point Fire Departments for emergency purposes. We are responsible for the design and implementation of all Town roadway, drainage and building construction projects. The Town Engineer reviews plans submitted to the Planning and Zoning Commission, the Wetlands Commission and the Water Pollution Control Authority. This construction season, along with our pavement management and drainage projects, we managed several renovation projects at the Broad Brook Elementary School for the Permanent Building Commission.

During the 2015-16 school year, East Windsor High School continued to implement its instructional focus. The East Windsor High School instructional focus is to improve problem solving skills for all students. In order to publicize the instructional focus, the faculty has adopted the slogan: Read It! Solve It! Write It! This year was highlighted with the completion of a brand new nurse's suite at the East Windsor Middle School. The suite is outfitted with the most up-to-date technology and provides three separate rooms for treatment and assessment. We developed new nursing checklists to be used during an emergency assessment. This year we trained 8 students in CPR and First Aid and 10 staff members in CPR/AED. We certified 18 staff members in medication delegation including all our PE/Health staff. The Staff Wellness Committee provided yoga classes to staff throughout the school year and created a walking challenge. Participation was very high in the walking challenge and everyone received a pedometer as part of our partnership with Cigna. We had a healthy cook-off between staff at each building. Our district-wide attendance increased this year. The Broad Brook School increased their attendance the most by a rate of .9%. The School Safety and Security Plan was revised to reflect our new district procedures. We continue to provide medical, oral and behavioral health services through our partnership with CHC and are looking forward to the new CHC site opening up at the Broad Brook School this fall.

ANNUAL REPORT

**Town of East Windsor**

**Fiscal Year 2015-2016**

The North Central District Health Department provides East Windsor with full-time health department services and is on call seven days a week, twenty-four hours a day for emergencies.

The Department is governed by a Board of Directors (Board of Health) in accordance with the General Statutes of Connecticut. Len Norton and Maria Whelden serve as East Windsor's representatives to the Board.

The Health Department is staffed by a Director of Health, a Chief of Environmental Services, a Director of Food & Institutional Services (all Registered Sanitarians), a part-time Emergency Response Coordinator, a part-time Health Educator, seven full-time sanitarians and a support staff of approximately 2.5 clerical workers. The Department has a medical advisor, a bookkeeper and contracts for auditing and legal services.

### THE PRIMARY MISSION

The primary mission of the NCDHD is disease prevention and surveillance and health promotion in the District's population. The District is responsible for programs in a number of areas including:

- \* Preventing epidemics and outbreaks of diseases, undertaking epidemiological investigations, follow-up and working to prevent the spread of communicable diseases such as tuberculosis, hepatitis, sexually transmitted diseases and the like.
- \* Inspection of restaurants, other food service establishments and facilities and the epidemiological investigations follow-up and prevention of the spread of food borne diseases.
- \* Safety inspections of schools, convalescent homes and other institutions.
- \* Water quality testing of bathing areas.
- \* Review, testing and approval of new septic systems, as well as the review and approval of plans for septic system repairs and/or expansion.
- \* Review of laboratory testing of well water for approval of new wells for homes.
- \* Provision of laboratory testing of drinking water, paint samples for lead, blood, stool and other samples as may be necessary in the investigation of outbreaks and illnesses.
- \* Investigation of complaints in regard to public health hazards, nuisances, rodent or insect control.
- \* Inspection of housing units in response to physician's positive lead blood tests in children.
- \* The provision and support of health education and prevention programs.
- \* Monitoring the health status of the population.
- \* Assistance to the Department of Energy and Environmental Protection upon request for help in collection of samples or for follow-up or investigation of specific problems.
- \* Development and implementation of Regional Points of Dispensing (POD) clinics to dispense medications or vaccinate for post exposure to biological agents, pandemic influenza or other natural outbreaks; all hazard emergency response plans to respond to, mitigate and recover from, natural and manmade disasters to protect the populations of the District.

**Highlights-**The North Central District Health Department tests bathing waters at the East Windsor Town Park on Reservoir Avenue. The areas tested satisfactory during the past summer; however, in the past, rain events have results in elevated bacteria counts which necessitated the closure of the beach for a few days. In general, this past year, building activity has increased throughout the District. The following septic and well related work took place in East Windsor. One new subdivision (three lots) soil test applications and plans were received for review.

- 11 - Permits to Discharge were issued through June 30, 2016
- 10 - Well Permits were issued.
- 13 - New septic system permits with corresponding soil tests and plan reviews.
- 22 - Repair septic system permits with corresponding soil tests and plan reviews.

46 - Building additions (decks, pools, sheds, garages, etc.) were reviewed. The Health District enacted Barber Shop, Beauty Salon and Nail Salon Regulations pursuant to state statutes to license and inspect these salon facilities. In East Windsor, 23 salons were inspected and licensed this past year with reinspections conducted as necessary.

The District inspects complaints related to housing, trash, rodents and insects, sewage and water quality and the food service industry (restaurants, etc.). Thirty-six complaints in total were received.

One of our main functions in East Windsor is the licensing and inspection of food service facilities providing protection against food borne illness to the public. There were 77 facilities, including three public schools licensed during this period with 143 inspection, 2 reinspections and 12 other food inspections conducted. Six plans were submitted for review for new or renovations to existing food service facilities along with their related inspection.

We received 26 temporary event permit applications. Each temporary event application received by our office is evaluated by a staff inspector. Depending on the complexity of the proposed food service, our department will inspect evening and weekend events as needed.

The Health District is responsible for conducting follow-up interviews and on some occasions, follow-up inspections related to possible food borne illness. The food borne alerts form (for single cases) and the enteric disease interview form (for confirmed cases) are both confidential and are submitted to the State Health Department for review once completed by our staff.

In addition to routine food service inspections, well water supply reviews for food service and other related food service inspection, we respond to and investigate food related complaints and possible food borne illness reports received by the department. The department also responds to, and provides follow-up to, certain food recalls.

Each year, seven public swimming pools are inspected and the pools are licensed.

Also each year, our department inspections and licenses four Hotels/Motels.

NCDHD inspected two day care facilities for annual safety and environmental health issues.

**Health Education Annual Report-** The Health District maintains a very active website ([www.ncdhd.org](http://www.ncdhd.org)) to inform the community. Primary current topics are updated monthly while recalls and timely health information and press releases are provided as they occur. The website also provides office locations and hours as well as select forms that are frequently used by the public.

The Health District is continuing exploratory work on long-term measures that can be put in place to make our communities healthier. Next steps will involve a public health assessment of the community. The Health Educator has also been preparing press releases to local media to educate and remind constituents about important ways to stay healthy or get healthier.

**Emergency Response/Bioterrorism Annual Report-** The Public Health Emergency Preparedness division collaborates with the District's Emergency Managers and regional and state response partners and community stakeholders to plan and prepare and recover from natural disasters, disease outbreaks, environmental emergencies, and acts of terrorism. The division participates in exercises and trainings through the year to exchange ideas and gain expertise which enables the department to strengthen preparedness strategies and improve plan development and facilitation.

**Environmental Health Annual Report-**The inspections and investigations are listed on the following pages. It should be noted that raw numbers are no indication of time spent or the relative complexity of inspection; therefore a comparison is only possible in the most general sense.

### AMERICAN HERITAGE RIVER COMMISSION

This summer, the American Heritage River Commission continued its testing for E. coli in the Scantic River. The results were posted weekly at the 3 prime entry and egress sites in an effort to alert users of the river, as to its condition. Several newspapers published articles on our testing. Our Face Book page is continuously updated with our activities and pictures, letting the Town residents know what we are doing. In July, we again held our cardboard boat race; the event raised \$200 for the 5 Corner Cupboard along with 74 pounds of donated food to help the pantry care for its clients this summer. AHRC members try to keep the passage clear for paddling on the Scantic River. In addition, members maintain the trails in the East Windsor section of the Scantic River State Park. A new section of trail measuring about 2 ½ miles has been marked out and some clearing started. State grant funding is enabling AHRC members to develop this extension to the trail in the State Park, where we hold our annual New Year's Day hike and the CT Trails Day hike in early June. Participation in this State event puts our town "on the map", even bringing non-residents into the area. AHRC volunteers are working year round to provide free, safe recreation.

### CONSERVATION COMMISSION

This year, the Agricultural Commission hosted a Farmers Coffee event at the Melrose Schoolhouse in late March to give the agricultural community an opportunity to meet and browse literature on information and programs benefitting agriculture from the USDA, CT Dept. of Ag. and the NRCS. The East Windsor Community Garden had a good year with 11 gardeners. Some progress has been made to bring water to the Garden via an existing well at the Town Park across the street. We cosponsored a public program with the CT Farm Bureau on pollinators at Scout Hall. The Ag. Commission supported the efforts of the Farmers Market, at the Trolley Museum, which was well attended and gained popularity.



## HISTORIC PRESERVATION COMMISSION

The Historic Preservation Commission happily has served another year looking to preserve the history and culture of East Windsor. Our continuing goals of sparking interest in these areas has generated hands on community events taking place in our historic cemeteries, Town buildings, waterways and beautiful properties. A major tool in achieving these goals is the Historic Preservation Commission webpage ( [eastwindsorhpc@gmail.com](mailto:eastwindsorhpc@gmail.com) ), which is linked to the Town of East Windsor Internet Home Page ([eastwindsorct.org](http://eastwindsorct.org) ). Remember, planning for the future requires preserving the past.



## AGRICULTURAL COMMISSION

This year, the Agricultural Commission hosted a Farmers Coffee event at the Melrose Schoolhouse in late March to give the agricultural community an opportunity to meet and browse literature on information and programs benefitting agriculture from the USDA, CT Dept. of Ag. and the NRCS. The East Windsor Community Garden had a good year with 11 gardeners. Some progress has been made to bring water to the Garden via an existing well at the Town Park across the street. We cosponsored a public program with the CT Farm Bureau on pollinators at Scout Hall. The Ag. Commission supported the efforts of the Farmers Market, at the Trolley Museum, which was well attended and gained popularity.

## PERMANENT BUILDING COMMISSION

The Permanent Building Commission was adopted by a Town ordinance at a Special Town Meeting on May 14, 1998 and took effect on May 29, 1998. The Building Commission meets when necessary (usually monthly) to conduct building related matters for various Town Agencies. The Commission, under the direction of the Board of Selectmen, oversees all new building construction, repairs & renovations. This year the Commission reviewed: 1) Broad Brook Elementary School modular classrooms progress. Project completed 2) Middle School nurse's office renovations. Project has been completed. 3) Alliance District School Buildings Grant: Renovations at the Broad Brook Elementary School including the cafeteria, offices, bathrooms and boiler. Project is substantially completed.

### BOARD OF ASSESSMENT APPEALS

The Board held public sessions at the Town Hall in March, 2016. A total of 36 appeals were heard: 13 real estate and 23 personal property cases.

During Fiscal Year 2015/2016, an additional session was held in September, 2015 for the purpose of hearing taxpayers' appeals on motor vehicle assessments only. Seven appeals were heard and acted upon.

The Board continues to serve as an appeal body for aggrieved taxpayers as well as to review and correct values set by the Assessor.

### INLAND WETLAND WATERCOURSES AND WATERCOURSES AGENCY



East Windsor Inland Wetland Watercourse Agency consists of five regular members and two alternates. Alan Baker currently serves as Chairman with David Menard as Vice-Chairman and Richard Osborn as Secretary. The other regular member is Rebecca Talamini. Currently, there is one vacancy for a regular member. Michael Sawka and Steve Smith serve as alternates. Regular meetings are held on the first Wednesday of each month with the Agency's main function to review, issue, deny or modify permits for all regulated wetlands/upland review areas in town. The IWWA is staffed through the Planning and Zoning Department. The staff handles applications and provides information to the public.

### PENSION AND RETIREMENT BOARD

The Pension and Retirement Board meets quarterly to oversee the Town's Pension and Other Post-Employment Benefits (OPEB) Trust Funds. This year, the Pension Board worked with our actuary firm, Milliman, Inc. to revisit the actuarial assumptions used when determining the Town's annual required contribution to the Plan. By doing so, the Pension Board has taken a pro-active measure to insure that the Plan is sustainable for years into the future. The Plan ended the fiscal year with a market value of \$21,696,219, an increase of \$573,289, despite a stagnant economy. The Pension Board works closely with our investment team at Webster Bank to monitor asset allocation in order to maximize yield in a volatile market. Looking forward, the Board will be entering into Pension Plan negotiations with the Town's bargaining units in 2017. The Board has spent many hours preparing for the negotiations with the intention of creating an affordable Plan, while maintaining our integrity with Town employees.

## ZONING BOARD OF APPEALS

The primary function of the Zoning Board of Appeals (ZBA) is to review and act upon applications for variances from the Zoning Regulations when it is determined that a literal interpretation of the law would create a unique hardship. The ZBA also hears and decides appeals where citizens allege that there is an error in an order, requirement, or decision made by the Zoning Enforcement Officer. Also the ZBA acts under the authority of the State Statutes to grant location approval for dealing in or repairing motor vehicles.

This year the ZBA held 9 regular meetings and 1 special meeting at which 11 variances were requested, with 8 being approved, 2 denied and 1 withdrawn. Two location approvals for motor vehicle licenses were granted this year, one for a repairer's license and one for a used car dealer's license. Application fees of \$1,450 were collected this past fiscal year.

## VETERAN'S COMMISSION

This year, the Veterans Commission sponsored our 16th annual Veterans Day road race with over 300 runners. This event is our major fundraiser. These funds are used to support our other activities which include hosting Memorial Day ceremonies on the town green and placement of American flags on all veterans graves and utility poles along the main streets of Warehouse Point and Broad Brook. Additionally, the commission presented two \$750.00 scholarships to deserving students and financially assisted a veteran and commission member who required home modifications to accommodate his handicap after a leg amputation. Each December, the commission participates in the national Wreaths across America program at the veterans cemetery in Windsorville. We are moving forward on a project to enhance monuments and improve landscaping at the town green. We desperately need donations for this project as it is expected to cost more than \$60,000.00. Donor forms and engraved paver order forms are available at town hall and online. The commission meets on the first Thursday of each month at 7PM at town hall.



## BOARD OF FINANCE

The Board of Finance saw many changes during the year, from the sad passing of board member Bob Little, to welcoming newly elected members Steve Smith, Bill Syme and Jim Richards. Much of the year was spent monitoring the current budget and approving a new budget for FY 17. The budget process was made much more difficult this year due to constantly changing grant numbers from the State of Connecticut. The loss of State aid impacted the mill rate, but the budget ultimately passed with a 1.82% increase in spending and a minimal mill rate increase to 30.93.

The Board also kept a careful eye on spending. The Town saw savings in several areas: employee health care costs, heating oil and gasoline budget surpluses, and savings due to centralized purchasing. At the end of the fiscal year, the Board received an in-depth analysis of legal costs. It was determined that many of the fees will be recouped from tax sales and reimbursements from our insurer. The tax collector's surplus of over \$400,000 helped to offset mid-year reductions in State aid; the Town ended the fiscal year with an increase to fund balance. In FY 16, over \$300,000 in supplemental appropriations for town infrastructure improvements were approved at Town Meeting.

**PLANNING AND ZONING**

The Commission reviews and acts on applications for Commercial and Residential development as well as proposed changes to the Plan of Conservation and Development, Subdivision, and Zoning Regulations such as the approved amendment for elderly independent housing. And this last year, workshops were held to derive goals and strategies for the future, in support of the upcoming Plan of Conservation and Development (2016).

The PZC is staffed through the Department of Planning and Development. Copies of all land use regulations can be viewed or purchased in this office located at the Town Hall. The Planning Office also has application forms, bylaws, and procedural checklists. Many of these items are now available on the Town's website: [www.eastwindsorct.com](http://www.eastwindsorct.com)

The PZC held 20 Regular Meetings and 1 Special Meeting. Applications received are broken down into the categories of Site Plan Reviews (5), Special Use Permits (7), and Subdivisions/Resubdivisions (2), for 4 new lots. The following fees were received by the East Windsor Planning and Zoning Commission during the past fiscal year: Hearing/Application fees \$5,410 and Open Space Fees \$10,000.


### FISCAL YEAR 15-16 Annual Financial Report:

The audited Annual Financial Report for the Town of East Windsor for June 30, 2016 will be filed with the Town Clerk's office and available for view online at [www.eastwindsorct.com](http://www.eastwindsorct.com) under Treasurer's Office Financial Information on January 1, 2017.

The Board of Finance established a tax rate of 30.31 for fiscal year 2016, which was levied on the October 1, 2014 Grand List.

The Budget for fiscal year 2016 was \$36,356,748. Total expenditures for fiscal year 2016 were \$35,649,952; total revenues were \$36,162,840. The Town also used \$304,386 in reserve funds for infrastructure improvements. All supplemental appropriations are approved at Town Meeting.

### REVENUES AND EXPENDITURES FOR FISCAL YEAR 2016



**East Windsor Park – 51 Reservoir Avenue, Broad Brook**

Located in the Broad Brook section of East Windsor, this facility contains 22 acres including a waterfront for swimming, 2 baseball/softball fields, 1 multi-use field, 1 basketball court, one tennis court and one volleyball court. The facility also contains a snack bar, on-site parking and grilling areas. A double-sided pavilion containing kitchen facilities can be rented for events.

**Pierce Memorial Park – Windsorville Road, Broad Brook**

Located in the Windsorville section of East Windsor, this facility contains 1 baseball/softball field, 1 basketball court and a small playground containing swings, slide and picnic grills.

**Town Hall Annex – 25 School Street, East Windsor**

Located in the Warehouse Point section of East Windsor, this facility contains 2 playgrounds, one of which is a Boundless Playground.

**Abbe Road – 28 Abbe Road, East Windsor**

Located to the rear of 28 Abbe Road (Scout Hall), this facility contains 2 soccer fields.

**Osborn Field – South Water Street, East Windsor**

Located in the Warehouse Point section of East Windsor, this facility contains 4 baseball/softball fields, a basketball court and a small play ground with swings.

**Prospect Hill Park – Prospect Hill Road, East Windsor**

Located in the Warehouse Point section of East Windsor, this facility contains 1 baseball/softball field, 1 basketball court and a playground containing swings, slide and merry-go-round.

**Volunteer Park – South Water Street, East Windsor**

Located in the Warehouse Point Section of East Windsor, this facility is opposite of Osborn field and contains a gazebo, picnic tables and barbecue grills.
