## Chairperson's Report:

-Update on the purchase of 81 Bridge Street: The title company was First American Title Company, they handled the closing. We purchased the building as of last week. We are getting a refund of \$8800.00 from the closing. I am not sure what the refund is for. I am going to Attorney Landolina office tomorrow to get all the paperwork and the refund check. The property is fully insured. The keys are turned over to the Chief. They did not charge us for the oil.

## **New Business:**

Set the mill rate: I Charlie Nordell, move to adopt and set the mill rate of 1.95 mills for the Warehouse Point Fire Districts' fiscal year July 1, 2022 to June 30, 2023, and record it with town hall, Austin Holden second. All in favor

Fire Marshal Fees: Motion made by Rachel Safford to recommend that the matter of the amended Fire Marshal Fee Ordinance be added to the annual meeting to allow the electors to vote on the matter, Austin Holden second. Discussion: Lou, we just received this information 5 minutes ago, we need to wait till the next meeting to discuss. Commission: we need this to be put on the annual meeting which is next month. Lou: we just got this information. Rachel, this was emailed out by Jill last Tuesday. Charlie, we have been discussing this for a few months. Discussion, Motion was rescinded by Rachel Safford and Austin Holden.

Motion made by Rachel Safford to approve the amended Fire Marshal Fee Ordinance as presented, Charlie Nordell second. All in favor

Double taxation: A letter sent to the BOS months ago, without response. Charlie, it was put on one of the BOS agenda without discussion. Lou: Keep it on the agenda under old business. Kevin: Was there FOI involved? Lou: Yes, there was without response. Kevin: We need to research this, we need to look into dates and time lines and contact the state. The district tax pavers have waited way to long. Discussion of taxes on 81 Bridge Street, we credited the seller \$2200.00 at closing, Attorney Landolina will look into this.

Kevin: Did we approve to move forward with the closing before the tax issue was resolved? Lou: The closing document was 1100 pages, we didn't vote on every item. Discussion of tax refund. We need to hear what how Landolina feels on this. Add tax discussion on the next agenda

Motion accept the budget for the fiscal year2022-2023 which was adopted by the voter in the amount of \$\$982,293.73, at the mill rate of 1.95 Charlie Nordell, Austin Holden second. All in favor
