It was explained that this is the property next to Killam Truck that Calamar Development is interested in purchasing. During their title search, they came across caveats that the title attorney wants cleared. In most cases, caveats are not released. Mr. Killam explained that at one time 20 and 26 North Rd had been one piece of property owned by James Nielsen. Mr. Killam provided two letters he came across from the WPCA to him. One regarding a public hearing concerning the assessment for his property and the other a notice of a levied assessment marked paid, dated with his check number and signed by the WPCA Office Manager. Mr. Killam asked that the caveats be released based on that letter. Attorney Lanza explained that the caveat is a notice that there could be an assessment. Was an assessment calculated? If it was levied and paid, it can be released. Mr. Killam reported that the title search came across caveats from 1971 which they want cleared and released. Attorney Lanza explained that the assessments were paid but caveats don't get released. Attorney Lanza asked Mr. Killam to have the title attorney call him and he will find out what they need to satisfy that the assessments have been paid. Mr. Killam thanked the Board and left the meeting at this time.

IT Status

Mr. Alibozek reported there had been some drops in email service. Mr. Alibozek explained that they had lost SCADA 1. A new plant computer was purchased, SCADA installed and iFix updated. During the loss, SCADA 2 picked up and there was no trouble with controls or lab reports.

This was not discussed.

XIII. New Business

Bill Sheet Review

Mr. Anderson reported the budget is on track.

Superintendent's Report

Mr. Anderson explained that Mr. Enderle was out for a left knee replacement and will be working on the budget while at home. Mr. Anderson gave information on a returned warrant to Attorney Lanza. The property, 13 Spring St, is an estate and has been returned by both Marshal Barton and Marshal Hubbs. Attorney Lanza will contact Probate Court. Mr. Anderson mentioned there were several employee training certificates in the meeting packet. Mr. Alibozek explained that Katherine Kneeland had three certificates. Konrad Karolczuk is the first employee to take part in the FEMA National Information Management System (NIMS) training. Mr. Karolczuk served 22 years with the Army and participates in the Town's Emergency Management Training.

Mr. Alibozek provided an information packet on the needed repairs to the old pump house. The concrete ceiling and floor in the old pump house building is deteriorating from hypochlorite leakage over the past twenty years. The packet contained information on the importance of the building, improvements that have been made to the building this past season, Woodard & Curran's Memorandum and Knowles Industrial Services quote for repairs. Mr. Alibozek explained that Woodard & Curran chose this company because they were highly suggested and produce good results. Attorney Lanza questioned why there was only one quote. He felt they should get more bids; that is a lot of money. As a tax payer he feels they should have more bids. Mr. Montstream would like to see another bid also. Mr. Montstream explained that the WPCF staff works hard to save money; he would feel better seeing another quote to be sure the price is within reason. Mr. Anderson felt they should go back to Woodard & Curran and get one or two more quotes; but the project has to be done on time. Mr. Alibozek explained that the hypochlorite season begins May 1st and they need to begin preparing for it April 1st. This project will take about 7 weeks; it needs to begin soon. Mr. Anderson explained the building needs to be functional when it has to be functional. The work has to get done. Mr. Montstream asked if

they could wait until October to do the repairs when the hypochlorite season ends. Mr. Alibozek will ask Woodard & Curran what the repercussions of delaying until October are. Mr. Riggott stated that he doesn't have a problem with spending the money. The repairs are needed.
