b. Superintendent's Report

Mr. Enderle explained that it's been really tough working with limited staff. A repair was made to the gravity belt thickener and the Gibbs drive. Mr. Enderle explained that Jim Burnham was a great help and he will be sending a thank you letter to him. With money left in the budget, Mr. Enderle realized that the large valves at the plant aren't holding and he would like to replace them all. The two new mechanics have started and they are skilled individuals. Mr. Anderson felt it was a good idea to get the product on site and not have to deal with a price increase. Mr. Enderle asked the board to make a motion authorizing the Superintendent to go outside of the bidding procedures because of the need to purchase a specific kind of valve. Mr. Richards felt this is an ongoing project that was already approved and only needed a supplemental appropriation. Mr. Anderson explained that although the WPCA is a separate entity, they are still part of the Town audit process. Mr. Richards feels they have started the project to replace the valves, why go out to bid if only one manufacturer can supply them. Mr. Anderson suggested approving the expenditure.
