Time and Place

Paul Anderson, Chairman, called the meeting to order at 7:00 p.m. at the WPCA Admin Building, 192 South Water St, East Windsor, CT

I. Pledge of Allegiance

II. Added Agenda Items

III. Election of Officers

Mr. Anderson stated that nominations were in order for the position of Chairman. Are there any nominations for Chairman? Mr. Richards nominated Mr. Anderson and Mr. Smith seconded the nomination. Mr. Anderson asked if there were any further nominations? Nominations were closed for Chairman.

Mr. Anderson stated that Nominations were in order for the position of Vice Chairman. Are there any nominations for Vice Chairman? VIII. Receipt of Applications

Ezedine, 179 So Main St, COM2021-006

Mr. Enderle explained that this is an existing commercial building that connected to the sewer this week. There was an as built with a lateral to the edge of the property. This was formerly Christmas Cars.

Noble Energy Real Estate/84 North Road EW LLC, 84 North Rd, COM2021-007

Mr. Enderle explained that this is a proposed car wash next to the Noble Gas Station. Mr. Enderle had identified in green where the car wash will go. Mr. Enderle spoke with Paul Dimmock of Noble Energy. They are estimating use of 3,337 gpd with a reclaim system. Mr. Enderle wanted to make Mr. Dimmock aware of the Three-Year Review. The other three car washed is town had proposed using reclaim systems but didn't and were assessed with large Three-Year Review charges. The 3,337 equates to 24 EDU's. This will result in an FCC in the amount of \$156,000.

X. <u>Legal</u>

Mr. Anderson reported that Attorney Lanza would be available by telephone if needed. Mr. Anderson explained that there would be a discussion requiring employees to get vaccinated; no decision will be made tonight. Mr. Anderson has concerns that the employees have contact with the public. Some employees have been vaccinated and some have not. Mr. Alibozek reached out to the Union for an opinion. Mr. Alibozek explained there are nine union members; six are vaccinated and three are not. He is not getting a response from the three unvaccinated employees other than they're not getting vaccinated. The Union is in favor of requiring the vaccination. This is not a grievable item. It was reported that Town Hall is having the same struggle. Mr. Smith reported that the vaccine currently has emergency authorized use. When it is approved, staff should be required to get vaccinated. If the state says it is required with full authorization, employees should be given a deadline to get vaccinated. It is a liability when dealing with the public. Employers can make employees get vaccinated. Mr. Richards feels staff needs to wear masks when dealing with the public if not vaccinated. This profession is a hot spot. Mr. Enderle explained that he is not comfortable making the decision. He has brought this

to the commission. He understands both sides. Mr. Anderson doesn't want the WPCA responsible for passing this on to someone else. Mr. Smith explained that a policy is needed with end dates. As an employer, you have the right to require employees to be vaccinated. There is a liability aspect. Mr. Alibozek explained that 6 employees have been vaccinated. Should they be looking at what the minority, the 3 employees want or the majority, the 6 employees. Mr. Enderle explained that he saw the Union letter. If mandated a Union member could grieve it. The Union is recommending getting the vaccine. Mr. Richards questioned why we aren't going forward. Mr. Smith stated that once the vaccine has full authorization, the employees will need to be vaccinated and given a deadline. Mr. Richards feels they need the following:

- 1. Full protocol
- 2. With full authorization, discuss a time frame
- 3. Require new hires to be vaccinated

Mr. Alibozek stated that the vaccine requirement needs to be across the board. Mr. Smith feels they should have Attorney Lanza put together language.

Mr. Anderson asked if there was anyone present on Zoom representing any properties in the public hearing, there was no one.

School Hill Water Association, Elaine Dr. Mr. Enderle explained that this is a private water supply. The State is requiring them to install a filtration device to remove nitrates. The device needs a place to backwash which is why they are connecting to the sewer. The FCC has been paid in full.

WAMN Properties LLC, 198 So Main St. Mr. Enderle explained that this property had a house that was demolished and a new 8-unit automotive use structure will be built. The had an existing EDU and will have 2 new.

D&R Real Estate LLC, 237 So Main St. Mr. Enderle explained that this is the Action Glass property. It had been on a septic system but is connecting to sewer, half of the FCC has been paid.

Donovan/Fortune, 106 North Rd. Mr. Enderle explained that this is an existing single family and all of the FCC has been paid in full.

Lawrence Farm LLC/United Ag & Turf, 111 So Main St. Mr. Enderle explained that this is a new commercial building and none of the FCC has been paid.

West River Farms LLC, 9 West River Rd. Mr. Enderle explained that this was a new single family and all of the FCC has been paid at the old rate of \$4,994. They received the old rate because they prepaid for their connections before the new rate was imposed.

West River Farms LLC, 11 West River Rd. Mr. Enderle explained that this was a new single family and all of the FCC has been paid at the old rate of \$4,994.

Ms. Wasik could not believe that something was being done. Mr. Enderle thanked Mr. Anderson for all he had done.

Future Meeting Methods

Mr. Anderson explained that the hybrid meetings will continue.

Bill Sheet Review

Mr. Enderle explained that bills were still come in for the prior years budget and not much has been spent from the new year.

Superintendent's Report

Mr. Enderle asked for an adjustment in the delinquent policy for this billing cycle. The policy currently states that delinquent letters would be sent out the first Tuesday of August. Mr. Enderle asked for a deferral until September 1st.
