## MINUTES OF REGULAR MEETING April 5, 2021

The East Windsor Zoning Board of Appeals (ZBA) held a meeting on Monday, April 5, 2021 via Zoom Meeting.

I. <u>Establish Quorum</u> – A quorum was established as Chairman Giner, Mystica Davis, Nolan Davis, and Steve Smith were present.

Chairman Giner gave the applicant a chance to not proceed with his application at this meeting as there were only 4 members present. The applicant indicated that he would like to proceed with his application.

IV. New Hearings

A. ZBA #2021-01 – Application of Central AS LLC, for location approval for a DMV Repairer's License and Used Car Sales at 198 South Main Street. (Map 022, Block 05, Lot 079) Zone B-2.

Tim Coon of J.R. Russo was present representing Bill Ezedine of Central AS, LLC. Mr. Coon shared his screen to show which parcel the application is for. He informed the Board that the applicant is proposing to demolish the existing house and construct a 9,600 SF building that will have up to 8 tenant spaces for automotive repair. There will be 55 parking spaces, serviced by public sewer, public water, natural gas, and an onsite stormwater system. Mr. Coon told the Board that his applicant has wetlands and planning and zoning approvals.

Chairman Giner clarified for the Board that this is not a variance and that we are acting as an agent of the DMV under the Connecticut General Statutes. Chairman Giner expressed that he could not see why this wouldn't be approved. He opened questions and comments to the Board members. There were no questions or comments from members of the Board.

Chairman Giner asked if anyone in the audience wanted to speak. No one from the public requested to speak.
